## WCPFC IUU VESSEL LIST FOR 2022

WCPFC18- 2021-30 2 November 2021

### Paper prepared by the Secretariat

#### Purpose

1. This paper presents the relevant information for the consideration and decision of WCPFC18 on the 2022 WCPFC IUU Vessel List.

### Background

2. The Sixteenth Regular Session of the Commission (WCPFC16) adopted the Conservation and Management Measure to Establish a List of Vessels Presumed to Have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO (CMM 2019-07<sup>1</sup>) which amended and replaced CMM 2010-06.

3. CMM 2019-07 requires the Executive Director to prepare a draft IUU Vessel List based on information received from Members, Cooperating Non-Members and Participating Territories (CCMs) at least 70 days before the annual meeting of the Technical and Compliance Committee (TCC). Paragraph 6 of this CMM further requires the Executive Director to transmit the draft IUU Vessel List, together with all the supporting evidence provided, to all CCMs, as well as to non-CCMs with vessels on the list, at least 55 days before the annual meeting of the TCC.

### Recommendations on the provisional WCPFC IUU Vessel List

4. TCC17 reviewed the current WCPFC IUU Vessel List for 2021. No changes are proposed to this list. The record of deliberations will be available in the draft TCC17 Summary Report from <u>https://meetings.wcpfc.int/meetings/tcc17</u>. The recommendation is provided in the box below with the relevant paragraph numbering.

<sup>&</sup>lt;sup>1</sup> The Seventh Regular Session of the Commission (WCPFC7) adopted CMM 2010-06 entitled 'Conservation and Management Measure to Establish a List of Vessels Presumed to Have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO' (which replaced the first such CMM; CMM 2007-03).

TCC17 recommended to WCPFC17 that the three fishing vessels **NEPTUNE**, **FULIEN No.1 and YU FONG 168** on the WCPFC IUU Vessel List in 2021 remain on that list for 2022.

6. WCPFC18 is invited, pursuant to CMM 2019-07, to adopt a WCPFC IUU Vessel List for 2022, considering the TCC17 recommendation to maintain the three vessels that are currently on the WCPFC IUU Vessel List and any other relevant information.

<sup>&</sup>lt;sup>2</sup> Supplementary note: In October 2015, the Executive Director wrote to: Chinese Taipei and Georgia requesting information on their vessel/s on the WCPFC IUU list, and to other RFMOs (CCAMLR, CCSBT, IATTC, ICCAT, IOTC, NPAFC & SPRFMO) to seek their cooperation with locating the vessels on the list. Georgia confirmed that the vessels Neptune and Fu Lien No 1 were no longer flying the Georgia flag. Chinese Taipei confirmed the Yu Fong 168 license was revoked in 2009 and the vessel owner financially penalized for violating the rules of not returning to port. Chinese Taipei further advised information was received from Thailand's notification to IOTC that the vessel landed their catches in the port of Phuket in the year 2013. On 17 November 2017, Chinese Taipei informed WCPFC that the Yu Fong 168 had been deregistered by Chinese Taipei. On 29 April 2020, WCPFC received further information from Chinese Taipei identifying the master of the Yu Fong 168 at the time of the IUU fishing activity who had been sanctioned.
