SUMMARY OF NOTIFICATIONS TO WCPFC OF CHARTER, LEASE OR OTHER MECHANISMS

WCPFC18-2021-IP11_rev3¹ 25 November 2021

Paper by Secretariat

Purpose

1. This paper tables a summary of all notified chartered vessels for the information of and review by the Commission. This paper responds to paragraph 6 of CMM 2019-08 *Conservation and Management Measure for the Charter Notification Scheme*.

Background

- 2. Since 2010, the WCPFC has had a Charter Notification Scheme under various versions of the CMM on Charter Notification. The current measure is CMM 2019-08 which expires on 28 February 2022.² A draft updated CMS workplan 2022-2024 considered by members at TCC17 includes a task to analyse and advise on any necessary modifications of this measure. TCC17 recommends the updated TCC workplan 2022 2024 for adoption by WCPFC18 (*draft TCC17 Summary Report Attachment G; draft TCC17 Summary Report, para 194)* (WCPFC18-2021-28 Reference document on TCC17 recommendations for Agenda 10).
- 3. In accordance with CMM 2019-08 paragraphs 2 and 3, each Member or Participating Territory can choose to notify the Commission of any vessel to be identified under the Charter Notification Scheme, for the purpose of conducting fishing operations in the Convention Area as an integral part of the domestic fleet of that chartering Member or Participating Territory.
- 4. Paragraph 7 of CMM 2019-08 also states: "Unless specifically provided in other CMMs, catches and effort of vessels notified as chartered under this CMM shall be attributed to the chartering Member or Participating Territory. Unless specifically provided in other CMMs, the chartering Member or Participating Territory shall report annually to the Executive Director catch and effort of chartered vessels in the previous year."

5. At WCPFC16 the Commission encouraged Chartering CCMs to report on their application of the chartering measure, to EEZs, high seas, or both EEZ and high seas (WCPFC16 Summary Report, paragraph 662).

Overview

6. Paragraph 5 of CMM 2019-08 tasks the Executive Director to make available to all CCMs information submitted under CMM 2019-08. Information received from CCMs on charter arrangements can currently be found in two places on the WCPFC Intranet.

<u>I. As part of the Record of Fishing Vessels:</u> where flag CCMs are expected in accordance with the RFV SSPs to confirm charter arrangements for their vessels are submitted in accordance with CMM 2014-03 (CMM 2014-03, RFV SSPs).

II. In the Charter Notification List maintained by the Secretariat: which records advice that chartering Members or chartering participating territories have advised the Secretariat as well as the appropriate flag CCM, in accordance with the WCPFC Charter Notification Scheme (CMM 2019-08 or its predecessor)

- 7. In 2021, as of 22 November 2021, the Secretariat received 11 submissions from 5 Members and Participating Territories containing notifications or updates related to the Charter Notification Scheme. At the time of writing this paper there were a total of 294 individual vessels (272 longliners, 20 purse seine vessels and 2 carrier vessels) that are notified under the Charter Notification Scheme CMM during the 2021 calendar year. In 2021, nineteen (19) individual longline vessels were notified to have a charter application area of "EEZ only", and the remaining vessels were either notified or inferred to have a charter application area of "EEZ and high seas". In addition, there were two (2) carrier vessels, that are notified under the Charter Notification Scheme for 2021 calendar year and beyond.
- 8. In accordance with paragraph 6 of CMM 2019-08, a summary of the list of notified charter vessels, with annual counts of individual vessels by Charter Notification period are presented in **Annex 1** attached to this paper.

Recommendation

9. WCPFC18 is invited to note the paper.
