The WCPFC Charter Notification Scheme was established under Conservation and Management Measure 2011-05 (which replaced CMM 2009-08 and extended the scheme until 31 December 2012).

In accordance with CMM 2011-05, each chartering Member of Participating Territory is to notify the Commission of any vessel to be identified as chartered in accordance with this measure by sending notification to the Executive Director. Only vessels listed on the WCPFC Record of Fishing Vessels or the WCPFC Interim Register of Non-CCM Carriers and Bunkers, and not on the WCPFC IUU list, or IUU list of another RFMO, are eligible for charter. Paragraph 5 of CMM 2011-05 instructs the Executive Director to make available to all CCMs information submitted under CMM 2011-05.

The WCPFC Secretariat currently maintains on the WCPFC secure CCM only part of the WCPFC website, copies of all current notifications under the WCPFC Charter Notification Scheme. In accordance with paragraph 6 of CMM 2011-05, a summary of all currently notified WCPFC chartered vessels is provided in Table 1. Table 1 includes:

- updated charter notifications from New Zealand for four vessels 2012/13;
- updated charter notifications from Fiji of eleven vessels until 1 Jan 2014;
- a charter notification from Korea of one vessel until 9 June 2016; and
- a charter notification from Kiribati of one vessel until

In accordance with paragraph 6 of CMM 2011-05, a summary of the current list of notified charter vessels is presented here.
