In preparation for JWG-07, members may wish to discuss the WCPFC Harvest Strategy for Pacific Bluefin Tuna Fisheries (HS 2021-01³) as well as the IATTC Resolution C-21-01 related to a long-term management strategy for Pacific Bluefin Tuna in the Eastern Pacific
