# REVIEW OF CCMs' IMPLEMENTATION OF, AND COMPLIANCE WITH, CONSERVATION AND MANAGEMENT MEASURES

WCPFC5-2008/18 20 November 2008

## Paper prepared by the Secretariat

### Introduction

- 1. The Commission's CMMs that apply equally to Members, Cooperating Non-Members and Participating Territories (CCMs) are listed in Table 1. These measures impose reporting and monitoring obligations on CCMs. A summary of reports received from various CCMs in respect of each CMM is presented at Table 2.
- 2. This paper updates information provided in WCPFC-TCC4-2008/10 (Rev.3) based on submissions by CCMs to the Secretariat since TCC4 in early October 2008. Supplementary information, prepared at the request of TCC4, and listing the names of CCMs in compliance with various reporting measures and obligations, and those not in compliance, is presented in WCPFC5-2008/IP06.

## Record of Fishing Vessels and Authorization to Fish

- 3. Under this measure, each CCM was required to submit to the Executive Director by 1 July 2005 particular information with respect to each vessel listed in its national record of fishing vessels entitled to fly its flag and authorized to fish in the Convention Area beyond its area of national jurisdiction. Since 1 July 2005, each CCM is required to notify the Executive Director within 15 days, or in any case within 72 hours before commencement of fishing activities in the Convention Area of:
  - a. any vessel added to its Record along with the information set forth in paragraph five (5) of Conservation and Management Measure-2004-01;
  - b. any change in the information referred to in paragraph five (5) with respect to any vessel on its Record; and
  - c. any vessel deleted from its Record along with the reason for such deletion in accordance with Article 24 (6) of the Convention.
- 4. At the time of preparing this paper, 23 CCMs and 3 non-CCMs (Ecuador, El Salvador and Panama¹) had provided records of their respective fishing vessels, as listed in Table 3. The Fourth Regular Session of the Commission (WCPFC4) in December 2007 granted a one-year exemption to Kiribati to allow six Ecuadorian, two El Salvadorean and one Panamanian purse seiners to fish within Kiribati's EEZ, on the condition that Kiribati require these vessels not to fish in the high seas in the WCPFC Convention Area.

5. A summary of the information provided by CCMs is presented in Table 4. Vessel details were submitted as MS Excel and pdf files in a range of formats. Nineteen CCMs and non-CCMs – Belize, China, Cook Islands, Ecuador, El Salvador, EU, Fiji, Japan, Kiribati, Korea, Marshall Islands, New Caledonia, New Zealand, Panama, Philippines, Chinese Taipei, Solomon Islands, Tuvalu and the U.S. - have submitted legible colour photographs of vessels as stipulated in paragraph 5(g) of CMM-2004-01.

### Authorizations to Fish

- 6. Although the WCPFC Record of Fishing Vessels database uses a vessel's International Radio Call Sign (IRCS) as the default WCPFC Identification Number (WIN), in cases where an IRCS has not been supplied, CCMs are expected to provide a WIN for those vessels. As reported to TCC2 and TCC3, some CCMs have assigned a number for the WIN while others have not.
- 7. Some CCMs provided information on the fishing areas in which vessels are authorized to operate. However, because several CCMs authorize vessels to fish on the high seas globally, the WCPC Record of Fishing Vessels is not an accurate indicator of active fishing capacity in the WCPO because it may include vessels that have never operated, or never plan to operate, in the WCPO.
- 8. To address this issue WCPFC4 agreed:
  - a. that before 1 July of each year, each Commission Member shall submit to the Executive Director a list of all vessels that appeared in its record of fishing vessels at any time during the preceding calendar year, together with each vessel's registration number, the WCPFC identification number (WIN), and an indication of whether each vessel fished for highly migratory fish stocks in the Convention Area beyond its area of national jurisdiction. The indication shall be expressed as (i) fished, or (ii) did not fish;
  - b. Members that operate joint-venture or charter arrangements that result in data reporting obligations being conferred to a party other than the flag State will make arrangements to ensure that the flag State can meet its obligations under paragraph 8 "a" above;
  - c. The WCPFC Record of Fishing Vessels shall identify those fishing vessels so listed that were active in the Convention Area in the preceding year, consistent with the information provided by Members under paragraph 8 "a" above;
  - d. The Executive Director shall use available information, including the information supplied by Members under paragraph 7 "a" above, to assist in the assessment of the implementation of relevant CMMs and resolutions for the annual consideration of the TCC.
- 9. At the time of preparation of this paper, only ten CCMs (Australia, Belize, Canada, EC, FSM, Fiji, Japan, Korea, New Zealand and the U.S.) had submitted their respective lists of vessels as described in paragraph 7(a) above.
- 10. While some respondents provided information on species and time periods for which the authorizations were valid, there was little or no evidence that the other authorization requirements were satisfied (paragraph 3, CMM-2004-01). These requirements include:
  - a. permitted activities by the vessel;
  - b. a prohibition of fishing, retention on board, transhipment or landing by the vessel in areas under the national jurisdiction of an other State except pursuant to any license, permit or authorization that may be required by such other State;
  - c. the requirement that the vessel keep on board the authorization issued; and
  - d. any other specific conditions to give effect to the provisions of the Convention, and conservation and management measures adopted pursuant to it.

- 11. WCPFC3 endorsed a TCC2 confirmation that only vessels flagged to CCMs may be licensed to operate in the WCPO, an agreement that there should be no amendments to CMM-2004-01 and a recommendation for a one-year phase-out period for those identified bunker and carrier vessels flagged to non-CCMs currently operating in the WCPO. WCPFC3 agreed on a set of regulations to be applied to such bunker and carrier vessels during this one-year period, including the maintenance by the Secretariat of a temporary register of carriers and bunkers. The Secretariat has maintained a temporary register of carriers and bunkers since February 2007.
- 12. WCPFC4 adopted the following recommendations of a small working group that considered a proposal by Marshall Islands regarding whether or not (and how) to allow the operation of non-CCM flagged carrier and bunker vessels on the high seas in the Convention Area:
  - a. the Commission should defer consideration of establishing a record of non-CCM carrier and bunker vessels:
  - b. the Commission should refer the original proposal from Marshall Islands, as amended in paragraphs 1 (c), 1(d), 11-16 and 19-22 of WCPFC4-2007/28 to TCC4 for consideration;
  - c. the Commission should encourage interested CCMs to work together before TCC4 to continue to develop this measure for adoption in 2008; and
  - d. the Commission should extend the current exemption for non-CCM carrier and bunker vessels for 2008 pending the work recommended above.
- 13. TCC4 recommended to WCPFC5 that the exemption for non-CCM carrier and bunker vessels be extended for a further year.

## CCMs' Records of Fishing Vessels

- 14. A total of 8,846 vessels are included in the records submitted to the Executive Director by CCMs since 1 July 2005. These cover small, medium and large-scale tuna fishing vessels (Table 4), vessels targeting tuna and other species, support vessels, and research and training vessels.
- 15. While it has not been possible to verify the information contained in each CCMs'Record, it is clear that not all the information required in CMM-2004-01 has been provided by all of those CCMs that submitted vessel records (Table 5). During 2007 and 2008 the Secretariat worked collaboratively with several CCMs to remedy deficiencies in their respective vessel records.

### WCPFC Record of Fishing Vessels

- 16. The online, searchable version of the WCPFC Record of Fishing Vessels available at <a href="http://www.wcpfc.int/vrecord/search.php">http://www.wcpfc.int/vrecord/search.php</a> was amended in mid-September 2008 to indicate whether or not a vessel either "fished" or "did not fish" for highly migratory fish stocks in the Convention Area beyond its area of national jurisdiction in the preceding year.
- 17. In order to more efficiently process vessel information provided for the purpose of maintaining the WCPFC Record of Fishing Vessels, it is proposed that during 2009, the Secretariat be tasked to develop an on-line system of vessel data entry. Such a system would allow each CCM flag State to enter the details of vessels for which it is responsible directly to the WCPFC Record of Fishing Vessels. This system will be programmed to accept data consistent with the provisions of the Convention, CMM-2004-01, or any other decisions of the Commission relating to information requirements for individual vessels (e.g. VMS) for the purpose of maintaining the WCPFC Record of Fishing Vessels.

# Conservation and Management Measures for Bigeye and Yellowfin Tuna in the Western and Central Pacific Ocean

18. Paragraph 1 of CMM-2005-01 states, among other things, that "Through the adoption of necessary measures, the total level of fishing effort for bigeye and yellowfin tuna in the Convention Area shall not be increased beyond current levels." A footnote to this paragraph required CCMs to

register their existing regional or bilateral fisheries partnership arrangements or agreements with the Commission in advance of WCPFC3 in 2006. At the time of writing this paper, the Secretariat had received information on 12 existing regional or bilateral fisheries partnership arrangements or agreements existing at that time, a summary of which is appended at Table 6.

- 19. Subject to other provisions in the Measure, CMM-2005-01 establishes effort levels for purse seine fisheries between 20°N and 20°S (paragraphs 7 to 10) and catch limits for the longline fishery (paragraph 17 to 19). CMM-2006-01 establishes capacity limits for fisheries not addressed in CMM-2005-01, excluding artisanal fisheries. Information relating to these provisions compiled by the Commission's data manager, SPC-OFP is appended at **Attachment 1**.
- 20. Paragraph 16 of CMM-2005-01 grants an exemption from the measure for developing skipjack purse seine fisheries, between 20°N and 20°S, that can provide verifiable evidence of minimal yellowfin and bigeye catch, with 100 per cent observer coverage, and with a legitimate development plan. This paragraph further states that existing plans shall be tabled at the Commission for information. As noted in Table 2, one CCM has provided to the Secretariat a development plan for developing skipjack fisheries.
- 21. Paragraph 4 of CMM-2006-01 states that CCMs whose vessels fish in areas beyond national jurisdiction shall develop management plans for the use of FADs (anchored and drifting) in areas beyond national jurisdiction which shall be submitted to the Commission by 1 January 2008. As noted in Table 2, five CCMs (Australia, Japan, New Zealand, Papua New Guinea and Solomon Islands) have provided FAD management plans to the Secretariat to date.
- 22. Paragraph 9 of CMM-2006-01 states that prior to TCC3, CCMs with purse seine vessels fishing in the Convention Area are required to develop and provide to the Executive Director, plans to require all purse seine vessels to retain on board, and then land, all skipjack, yellowfin and bigeye tuna, except fish unfit for human consumption for reasons other than size, including provisions outlining how such plans would be implemented and enforced (Catch Retention Plans). To assist CCMs with purse seine vessels in the Convention Area to complete Catch Retention Plans pursuant to CMM-2006-01, on 26 June 2007 the Secretariat circulated to all CCMs a suggested set of guidelines for the preparation of such plans. As noted in Table 2, four CCMs (Australia, New Zealand, Solomon Islands and Vanuatu) have provided Catch Retention Plans to the Secretariat.

## **Conservation and Management Measures for South Pacific Albacore**

- 23. Paragraph 1 of CMM-2005-02 states that CCMs shall not increase the number of their fishing vessels actively fishing for South Pacific albacore in the Convention Area south of 20°S above current (2005) levels or recent historical (2000-2004) levels. There have been difficulties in monitoring CMM-2005-02 with the data provided to the Secretariat at this point. Information specifically listing the number of vessels fishing for South Pacific albacore south of 20°S per year has been provided by Australia, Belize, New Caledonia and New Zealand (Table 7), but could potentially be obtained from other CCMs if they provided complete operational data.
- 24. Except for Australia, Belize, New Caledonia and New Zealand, the following problems currently exist:
  - a. the Secretariat has only been provided with aggregate catch/effort, without vessel numbers, for the distant-water fleets fishing south of 20°S, so it is impossible to determine annual active vessel numbers for these fleets; and
  - b. annual active vessel numbers could be obtained for fleets operating south of 20°S using operational data, when available, but the coverage of operational data would need to be 100 per cent.

## Conservation and Management Measures for North Pacific Albacore

25. Conservation and Management Measure-2005-03 states that all CCM shall report:

- a. all catches of North Pacific albacore to the WCPFC every six months, except for small coastal fisheries which shall be reported on an annual basis. Such data shall be reported to the Commission as soon as possible and no later than one year after the end of the period covered; and
- b. annually to the WCPFC all catches of albacore north of the equator and all fishing effort north of the equator in fisheries directed at albacore. The reports for both catch and fishing effort shall be made by gear type. Catches shall be reported in terms of weight. Fishing effort shall be reported in terms of the most relevant measures for a given gear type, including at a minimum for all gear types, the number of vessel-days fished. The first report was due on April 30, 2006 covering calendar year 2004.
- 26. At the time of writing of this paper the Secretariat has received information on estimated catches of North Pacific albacore covering recent activities for the following fleets:
  - a. Canada Troll (2004-2007);
  - b. Chinese Taipei distant-water and offshore longline (2004-2007);
  - c. Cook Islands troll (hard-copy only), longline (2007);
  - d. Japan longline (2004-2005);
  - e. Japan pole-and-line (2003-2006);
  - f. Japan purse seine (2004-2006);
  - g. Korea longline (2004-2007);
  - h. USA troll (2004-2007);
  - i. USA longline (2004-2007); and
  - j. Vanuatu longline (2004-2006).
- 27. The scope of data provided varies among CCMs. Some CCMs provide all the data required by the Measure, others report catch but not effort, and a few report effort in terms of "days fished".

# Conservation and Management Measures to Mitigate the Impact of Fishing for Highly Migratory Fish Stocks on Seabirds

28. Paragraph 4 of CMM-2007-04 states that "For research and reporting purposes, CCMs with longline vessels that fish in the Convention Area area south of 30°S or north of 23°N shall submit to the Commission in part 2 of its annual report for 2007 (due in 2008) information describing which of the mitigation measures in Table 1 they require or will require their vessels to use, as well as the technical specifications for each of those mitigation measures. Each such CCM shall also include in its annual reports for subsequent years any changes it has made to its required mitigation measures or technical specifications for those measures." As noted in Table 2, three CCMs have provided information about mitigation measures to the Secretariat under the now-rescinded CMM-2006-02, and these three CCMs and another CCM have provided the information required under paragraph 4 of CMM-2007-04 in their respective Annual Report (Part 2) for 2007.

## Conservation and Management Measure for Swordfish in the South West Pacific

29. Paragraph 4 of CMM-2006-03 states, in part, that "...CCMs shall provide information to the Commission, by 1 May 2007, on the number of their vessels that have fished for swordfish in the Convention Area south of 20°S, during the period 2000-2005, and in doing so, nominate the maximum number of vessels that shall continue to be permitted to fish for swordfish in the area south of 20°S." At the time of writing this paper, the Secretariat has received this information from Australia, Belize, Cook Islands, EU, Korea, New Caledonia, New Zealand, Chinese Taipei and the U.S. A summary of the responses relating to CMM-2006-03 received by the Secretariat is presented in **Attachment 2**.

30. In relation to CMM-2006-03, Vanuatu has provided monthly longline catches (mt) of swordfish taken south of 20°S for the period 2002-2005 but not the number of vessels involved.

# Conservation and Management Measure for Striped Marlin in the Southwest Pacific

- 31. Paragraph 4 of CMM-2006-04 states, in part, that "...CCMs shall provide information to the Commission, by 1 July 2007, on the number of their vessels that have fished for striped marlin in the Convention Area south of 15°S, during the period 2000-2004, and in doing so, nominate the maximum number of vessels that shall continue to be permitted to fish for striped marlin in the area south of 15°S. CCMs shall report annually to the Commission the catch levels of their fishing vessels that have taken striped marlin as a bycatch as well as the number and catch levels of vessels fishing for striped marlin in the Convention Area south of 15°S."
- 32. At the time of writing this paper, the Secretariat has received information from Australia, Cook Islands, Korea, New Caledonia, Chinese Taipei and the U.S on the respective numbers of vessels that have fished for striped marlin in the Convention Area south of 15°S, during the period 2000-2004. The Secretariat has received information from New Caledonia and the U.S. on the catch levels of fishing vessels that have taken striped marlin as a bycatch as well as the number and catch levels of vessels fishing for striped marlin in the Convention Area south of 15°S. Vanuatu has provided monthly longline catches (mt) of striped marlin taken south of 15°S for the period 2002-2005 but not the number of vessels involved.
- 33. A summary of the responses relating to CMM-2006-04 received by the Secretariat is presented in **Attachment 3**.

## **Annual report to the Commission**

34. At TCC1 in 2005 CCMs agreed to provide an Annual Report to the Commission, the purpose of which is to report relevant information to the Commission on their respective fishing activities during the preceding calendar year, and management and compliance issues during the present year.

Annual Report (Part 1)

35. Part 1 of the Annual Report relating to information on fisheries, research and statistics was to have been submitted by 13 July 2008 or one month before the Fourth Regular Session of the Scientific Committee (SC4). While many of the Part 1 reports were submitted well after the due date, at the conclusion of the SC4 meeting, the Secretariat had received Part 1 reports from 26 CCMs.

Annual Report (Part 2)

- 36. In relation to the format of Part 2 of the Annual Report, WCPFC3 endorsed TCC2's recommendations that:
  - a. the revised template for Part 2 of the Annual Report (Attachment K of the WCPFC3 Summary Report) be adopted for future reports;
- b. Part 2 of the Annual Report be completed on a calendar year basis and submitted to the Secretariat by 31 July each year;
- c. the Commission invite the SC to review Part 1 of the Annual Report in light of its relationship with Part 2, including its consistencies (such as reporting periods and submission times); and
- d. the Secretariat be tasked with preparing guidelines, including minimum standards, for the completion of Part 2 of the Annual Report. These guidelines should be focused to ensure that a minimum level of consistency is achieved without being overly prescriptive.
- 37. Part 2 of the report relating to management and compliance covering the period 1 January-31 December 2007 was to be submitted by 31 July 2008.
- 38. In relation to "d" above, the Secretariat circulated a set of guidelines to CCMs in mid-May 2007.

- 39. TCC4 reviewed the issue of Annual Report (Part 2) templates and agreed that the Secretariat issue enhanced guidelines to which will be attached the current templates that have been considered by TCC. CCMs will be invited at WCPFC5 to propose a template for 2009.
- 40. Preparation of the Annual Report provides an ideal opportunity for CCMs to report progress on the following issues:
  - a. CCMs' implementation of the IPOA-Seabirds, including, as appropriate, the status of their National Plans of Action for Reducing Incidental Catches of Seabirds in Longline Fisheries (CMM-2007-04);
  - b. Resolution-2005-04 'Resolution to Mitigate the Impact of Fishing for Highly Migratory Fish Species on Sea Turtles' (Beginning in 2006, CCMs shall include in their Annual Report to the Commission [Part 2] a report on the steps taken to implement this resolution);
  - c. Progress by concerned CCMs with the development of a comprehensive catch documentation scheme covering all catch; and
  - d. Progress by CCMs with efforts to exercise reasonable restraint in expanding fishing effort on the south-west Pacific swordfish stock<sup>2</sup>.
- 41. The Secretariat had received 14 Part 2 Reports for the period 1 January-31 December 2007 from CCMs prior to TCC4. At the time of writing of this paper 28 Part 2 Reports for this period had been received.

**Outstanding Annual Reports** 

- 42. WCPFC4 was advised that:
  - a. Part 1 of the Annual Report by CCMs was submitted to the Commission for 2006 by 24 CCMs, although six (6) reports were outstanding at the time of WCPFC4; and
  - b. Part 2 of the Annual Report by CCMs for 2006 was received from 20 CCMs.
- 43. In addition to these outstanding reports for 2006, six (6) CCMs were yet to submit Annual Reports (Part 2) to the Commission for 2005. The Chair urged all CCMs with outstanding reports to submit them to the Secretariat as soon as possible.
- 44. Table 8 lists the numbers of Annual Reports that have been provided to the Secretariat to date with the numbers of outstanding reports in parenthesis.
- 45. WCPFC5 is invited to note, and provide advice and recommendations, as appropriate, in relation to:
- a. the different formats used by CCMs for the provision of vessel information for the WCPFC Record of Fishing Vessels (para.5 above);
- b. the provision of a WIN (para.6);
- c. details of fishing areas (para.7);
- d. details regarding active/inactive vessels (para.9);
- e. the requirements of paragraph 10;
- f. the referral to TCC4 for consideration of the original proposal by Marshall Islands (as amended) regarding whether or not (and how) to allow the operation of non-CCM flagged carrier and bunker vessels on the high seas in the Convention Area (para.12);
- g. the extension of the current exemption in relation to non-CCM flag carriers and bunkers (para.12);

- h. information relating to an authorization to fish (para.14);
- i. the proposal to develop an online data entry system for the WCPFC Record of Fishing Vessels (para.17);
- j. bilateral and multilateral partnership agreements registered with the Commission (para.18);
- k. note Tables 1, 2 and 3 of Appendix 1 in relation to purse seine fishing effort and longline catches relative to the provisions of CMM-2005-01 and information for other commercial fisheries in respect of CMM-2006-01;
- 1. note five (5) FAD management plans have been received by the Secretariat (para.21);
- m. note four (4) catch retention plans have been received by the Secretariat (para. 22);
- n. except for Australia, Belize, New Caledonia and New Zealand, the lack of information available to the Secretariat in relation to CMM 2005-02 (para.23);
- o. the lack of consistency in information received from CCMs in respect of the reporting requirements provided for in CMM-2005-03 (para.27);
- p. note three (3) CCMs responded to the requirements of CMM-2006-02 in respect of seabird mitigation, and that these three CCMs and another CCM have responded, during 2008, to the requirements of CMM 2007-04 (para.28);
- q. that nine (9) CCMs provided information on the number of vessels that fished for swordfish in the south west Pacific consistent with CMM-2006-03 (para.29);
- r. that five (5) CCMs provided information on the number of vessels that fished for striped marlin in the south west Pacific consistent with CMM-2006-04 (para.32);
- s. the late submission of Part 1 reports by many CCMs, although 26 were received by the end of SC4 (para.35);
- t. the late submission of Part 2 reports for 2008; only 14 were received prior to TCC4. This makes any analysis of the information contained in Part 2 reports in advance of TCC extremely difficult for both CCMs and the Secretariat (para.41); and
- u. the number of Part 1 and Part 2 reports outstanding for previous years (para.44).
