<sup>207.</sup> WCPFC15 agreed on an interim target reference point (TRP) for south Pacific albacore at 56 percent of spawning stock biomass in the absence of fishing (0.56 SBF=0)<sup>1</sup> with the objective of achieving an 8 percent increase in catch per unit of effort (CPUE) for the southern longline fishery as compared to 2013 levels.<sup>1</sup> If a future stock assessment indicates that this interim TRP will not result in the desired longline CPUE, then the interim TRP will be revised in order to meet this objective. The TRP shall be reviewed every 3 years, consistent with the SP albacore assessment schedule.
