#### Introduction

- 1. At the Fourth Regular Session of the Technical and Compliance Committee (TCC4) held at Pohnpei, Federated States of Micronesia from 2-7 October 2008, the Committee reviewed WCPFC-TCC4-2008/10 (Rev.3) on the subject of a compliance review and enforcement of management measures. It was noted with great concern that many CCMs had not met their reporting obligations with respect to various measures, and CCMs were urged to bring their reporting up to date in advance of WCPFC5.
- 2. TCC4 directed the Secretariat to prepare a table for consideration of WCPFC5 which would list the names of CCMs in compliance with various reporting measures and obligations, and those not in compliance. TCC4 noted that failure to provide information constitutes a failure to comply with the measure in question. TCC4 recommended to WCPFC5 that, depending on the response by CCMs to bring their reporting up to date in advance of WCPFC5, the Commission may wish to consider remedial action, including sanctions, for failure to comply.

### Organisation of information requested by TCC4

- 3. The information requested by TCC4 is organized into three tables, as follows:
  - i. CCMs' reporting obligations with respect to WCPFC Measures (Table 1);
  - ii. CCMs' reporting obligations with respect to CMM-2004-01 (Table 2); and
  - iii. CCMs' other reporting obligations (Table 3).

#### Recommendation

- 4. WCPFC5 is invited to:
  - note the compliance and non-compliance by respective CCMs;
  - consider remedial action for failure of CCMs to comply with their reporting obligations (refer paragraph 209, TCC4 Summary Report).
