CCMs' RESPONSES TO WCPFC CIRCULAR 2008/21, 16 OCTOBER 2008 – ENHANCED GUIDELINES FOR CCMs' PREPARATION OF ANNUAL REPORT (PART 2)

Paper prepared by the Secretariat

Introduction

- 1. At the 4th Regular Session of the Technical and Compliance Committee (TCC4) that met at Pohnpei, Federated States of Micronesia from 2-7 October 2008, the issue of a template for CCMs' preparation of the Annual Report (Part 2) was reviewed. TCC4 agreed that the Secretariat issue enhanced guidelines to which will be attached the current templates that have been considered by TCC. These enhanced guidelines are appended at Attachment 1.
- 2. At TCC4, CMMs were invited by the TCC Chair to comment by 10 November 2008 to the Secretariat regarding the current templates. CCMs will then be invited at the 5th Regular Session of the Commission (WCPFC5) to propose a new template for 2009.

CCM Responses to WCPFC Circular 2008/21

- 3. The Secretariat received responses from Australia, Belize, Cook Islands, Japan, New Zealand and Chinese Taipei. Three of these CCMs preferred the template attached at Appendix B of Attachment 1, one CCM preferred the template attached at Appendix A of Attachment 1 and two CCMs had no preference for either template.
- 4. In addition to expressing their preferences for the templates, some of the CCMs that responded to WCPFC Circular 2008/21 provided additional comments. Some of these comments are presented below.
 - i. The template attached at Appendix B of Attachment 1 is "user-friendly".
 - ii. Given the importance of annual reporting by CCMs, the added detail in Appendix B will provide the Commission with a greater level of understanding of the status of CMMs and usefully inform the future work of the Commission as we refine or adopt future measures.
 - iii. We support efforts to collect more detailed data on the implementation of CMMs.
 - iv. Our preference is for a simpler form of template rather than one that is more detailed and complex.
 - v. Not only the frequency of activities by individual CCMs but also the numbers of activities should be acceptable.
 - vi. The Secretariat should be tasked, following each WCPFC session, with updating the template to include or exclude CMMs, or Resolutions, as required.
 - vii. The template should not be revised frequently.

- viii. We recommend that an insertion should be made in the Part 2 template to accommodate reporting by CCMs of their "active" vessel lists.
- ix. The template attached at Appendix B of Attachment 1 provides a good starting point for discussions at WCPFC5 on the new template.

Discussion

5. CCMs are invited to propose a new template for the Annual Report (Part 2) for use in 2009.

ANNUAL REPORT TO THE COMMISSION - PART 2

ENHANCED GUIDELINES

Introduction

Commission Members, Cooperating Non-Members and Participating Territories (CCMs) have agreed to provide an 'Annual Report to the Commission', the purpose of which is to report relevant information to the Commission on fishing activities of CCMs, including management and compliance issues. This report is to include all fishing activities undertaken within the Convention Area.

The Annual Report to the Commission comprises two parts:

Part 1 - primarily relating to information on fisheries, research and statistics; and

Part 2 - relating to management and compliance.

Part 1 – Fisheries Research and Statistics

Part 1 of the Annual Report to the Commission primarily relates to scientific information and is not addressed here.

Part 2 – Management and Compliance

The information provided in Part 2 reports is critical to the effective functioning of the Technical and Compliance Committee.

Timing of submission of Part 2

Part 2 of the Annual Report to the Commission is to be submitted to the Commission Secretariat by July 31 each year.

Period of coverage of Part 2

Part 2 of the Annual Report to the Commission is to cover the period from 1 January through 31 December of the previous year.

Guidelines for preparation of the Annual Report (Part 2) by CCMs

In relation to the format of Part 2 of the Annual Report, WCPFC3 endorsed TCC2's recommendations that:

- a. the revised template for Part 2 of the Annual Report (Attachment K of the WCPFC3 Summary Report be adopted for future reports;
- b. the Secretariat be tasked with preparing guidelines, including minimum standards, for the completion of Part 2 of the Annual Report. These guidelines should be focused to ensure that a minimum level of consistency is achieved without being overly prescriptive.

In relation to "b" above, the Secretariat circulated a set of guidelines to CCMs in mid-May 2007.

The Fourth Regular Session of the Technical and Compliance Committee (TCC4) agreed that the Secretariat issue enhanced guidelines to which will be attached the current templates that have been considered by TCC, to be circulated by 16 October 2008. The following sections 2.1 to 2.5 are enhanced guidelines to CCMs regarding completion of Part 2 of the Annual Report. The current templates that have been considered by TCC are attached, as follows:

- a. Attachment K of the WCPFC3 Summary Report, attached at Appendix A; and
- b. Attachment 4 of WCPFC Circular 2008/03, attached at Appendix B.

An example of a completed Part 2 Report using Appendix B as a template is attached at Appendix C.

2.1 Implementation of Conservation and Management Measures

- 2.1.1 In accordance with Article 23, CCMs are required to report on steps they have taken to implement the Conservation and Management Measures (CMMs) adopted by the Commission (Table 1)¹ and report on CCM measures adopted for conservation and management measures of highly migratory fish stocks (HMFS) in areas under national jurisdiction. For each CMM, CCMs are required to respond 'Yes', 'No' or 'Partial' in relation to whether or not they have implemented it. In cases where a CMM has entered into force but an effective date does not fall within the reporting period, CCMs should respond 'No not yet in effect'. In cases where the CMM is not applicable to a CCM because of an exemption (e.g. exemptions for Small Island Developing States and Territories), CCMs should respond 'Not Applicable'.
- 2.1.2 If the response is 'No', for a particular CMM, the CCM is required to explain why it has not implemented this CMM.

If the response is 'Yes' for a particular CMM, CCMs are required to state what national measure/actions they have taken to implement this CMM. In respect of the 2005 CMMs, CCMs are encouraged to report the exact limits they consider applicable to their respective fleets².

- 2.1.3 CCMs are also required to report on measures they have adopted for regulating the activity of vessels flying their flags that fish in the Convention Area [Article 23(4)]. Examples of such measures are:
 - (a) vessel registration and authorization procedures;
 - (b) control of fishing vessels;
 - (c) instruction/education/extension programs for industry, including vessel owners, operators, crews and fish receivers/buyers;
 - (d) port access and inspections (such as the FAO port measures if applicable).
- 2.1.4 CCMs are encouraged to report on their implementation of Commission Resolutions, particularly the research and information-reporting provisions of these resolutions.

2.2 Monitoring and Inspection Activities

- 2.2.1 CCMs are required to list the particular monitoring and inspection activities conducted and the frequency of each activity (hourly, daily, weekly, monthly, annually), specifically addressing each of the following:
 - (a) vessel monitoring systems (VMS);
 - (b) transhipments;
 - (c) transhipment inspections;
 - (d) at-sea inspections;
 - (e) port inspections;
 - (f) observer monitoring;
 - (g) monitoring of trade and domestic distribution of highly migratory fish species;

¹ The Annual Report to the Commission (Part 2) template will be annually updated based on Decisions of the Commission. The CMMs that entered into force on 15 February 2008 will need to be accommodated in the 2008 Annual Report (due for submission by July 31, 2009) but not in the 2007 Annual Report.

² Example 1: In respect of paragraph 17 of CMM-2005-01, what is the particular limit for a CCM relating to, "The catch of bigeye....for the next 3 years shall not exceed the average annual bigeye catch for the years 2001-2004 or the year 2004?"

Example 2: In respect of paragraphs 1 and 2 of CMM-2005-02, what was the maximum number of the CCM's vessels that actively fished for South Pacific albacore in the Convention Area for 2005 or the previous five years and what are their catches?

- (h) inspections of domestic-only vessels; and
- (i) high seas boardings and inspections of flag vessels.
- 2.2.2 CCMs are also encouraged to provide clarifying comments on each of these monitoring and inspection activities. The information provided in this section should be in a summarised form.

2.3 Surveillance Activities

- 2.3.1 CCMs are required to list the particular surveillance activities they undertook and the frequency of each activity (hourly, daily, weekly, monthly, annually), specifically addressing each of the following:
 - (a) sea-going patrols in national waters;
 - (b) sea-going patrols on the high seas;
 - (c) aerial patrols of national waters; and
 - (d) aerial patrols of the high seas.
- 2.3.2 CCMs are also encouraged to provide clarifying comments on each of these surveillance activities. The information provided in this section should be in a summarised form.

2.4 Investigations and Prosecution Activity

2.4.1 CCMs are required to list their investigations and prosecution activities related to compliance with the Convention and with the Commission's conservation and management measures. They should indicate the number of investigations undertaken and the reasons for their being undertaken. Of those undertaken, they should indicate the number that have been resolved, along with summary descriptions of the outcomes, indicating, for example, whether or not a prosecution was successful and whether or not any financial or other penalties (e.g. IUU listing) were imposed. The information provided in this section should be in a summarised form to the level of detail that domestic requirements allow.

2.5 Further MCS measures taken and other relevant information

- 2.5.1 CCMs are required to provide information on any further MCS measures taken and other relevant information. Examples include:
 - (a) relevant changes to national legislation;
 - (b) implementation of trade measures (if adopted by the Commission);
 - (c) annual reporting by cooperating non-Members (to maintain co-operating status);
 - (d) prompt reporting of IUU fishing activity [Article 25(2,3)] and action taken in compliance with CMM-2007-03.
 - (e) estimated IUU catch within the EEZ; and
 - (f) reporting of any actions undertaken through an RFMO with respect to National Plans of Action or International Plans of Action.

REVISED PART 2 REPORTING TEMPLATE ANNUAL REPORT TO THE COMMISSION

Purpose: To provide relevant information to the Commission on fishing activities of CCMs and cooperating non-CCMs including management and compliance issues. The report should include all fishing activities being undertaken within the Convention Area.

(To be submitted by July 31 each year. Part 2 to cover the period 1 January – 31 December of the previous year.)

2.1 IMPLEMENTATION OF CONSERVATION AND MANAGEMENT MEASURES

CCMs are required to report on the steps they have taken to implement the conservation and management measures established for the Convention Area. In addition, CCMs are to inform the Commission of measures they have adopted to conserve and manage highly migratory fish stocks (HMFS) in the Convention Area.
