## REVISED PROVISIONAL IUU VESSEL LIST DATED 29 NOVEMBER 2008

#### Introduction

1. CMM-2007-03 [Conservation and Management Measure to Establish a List of Vessels Presumed to have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO] requires that, at its annual meeting, the Technical and Compliance Committee (TCC) adopts a Provisional IUU Vessel List (Paragraph 14 [i]). The Fourth Regular Session of the TCC (TCC4) held at Pohnpei, Federated States of Micronesia from 2-7 October 2008, agreed to include the *Jing Chuen No.68* on the Provisional IUU Vessel List and noted that the vessel shall be subsequently removed from the list once France confirms the payment of assessed fines is complete (Paragraph 97, TCC4 Summary Report).

2. With respect to the Provisional IUU Vessel List, all vessels contained in WCPFC-TCC4-2008/11 were reviewed. A Provisional IUU Vessel List is appended as Attachment F of the TCC4 Summary Report.

#### Discussion

3. On 29 November 2008 the WCPFC Executive Director was formally advised by France that the payment of assessed fines for the *Jing Chuen No.68* was complete. The Provisional IUU Vessel List was subsequently revised to remove the *Jing Chuen No.68* from the list. The revised Provisional IUU Vessel List dated 29 November 2008 is appended at **Attachment 1**.

#### Recommendation

4. WCPFC5 is invited to note the revised Provisional IUU Vessel List dated 29 November 2008 as part of its decision making in relation to the adoption of a WCPFC IUU Vessel List.
