TCC18 Proposed Schedule and Update on Meeting Arrangements

Dear Colleagues

As advised in Circular 2022/46, I am writing to provide an update on preparations for the 18th Meeting of the WCPFC Technical and Compliance Committee (TCC18), including advising on the proposed schedule for the meeting. As outlined in my previous letter, I have been consulting with the CMS-IWG Chair, the Audit Points and RBAF leads and the Secretariat to consider how to best structure the online TCC18 meeting to progress the CMS Future Work tasks assigned to us by WCPFC18.

TCC18 Schedule

The proposed TCC18 Schedule is available on the TCC18 meeting page and is attached to this circular (WCPFC-TCC18-2022-01). In short, I propose to follow a similar structure to previous TCC meetings, with the time usually reserved for the Compliance Monitoring Review process set aside for small working group discussions on the various aspects of the CMS Future Work (primarily focused on the Audit Points and RBAF, but also progressing the Aggregate Tables, CCFS development and observer participation tasks to the extent possible).

Plenary will commence on day one (Wednesday), with days two and three (Thursday and Friday) set aside for SWG discussions, before moving back into plenary on day four (Saturday). Sunday will be set aside as a rest day. I am hopeful that the SWGs will be able to make sufficient progress by that point that we (myself, the CMS-IWG Chair and SWG leads, and the Secretariat) will be able to utilise the rest day to synthesise overarching advice on the future CMS for TCC's consideration. A later, shorter session is scheduled for day five (Monday) to continue SWG and/or plenary work. Day six (Tuesday) will be the final day of plenary.

Noting the long agenda and recognising that last year's meeting ran consistently over time, I have extended meeting days by one hour – hence plenary will run from 10am to 3pm

Pohnpei time (including a half hour break), with the exception of day five (Monday) which will be 3-5pm.

I will work with the CMS-IWG Chair and workstream leads in the coming weeks to plan the timing for the SWG work that will take place throughout the meeting. I am aware of the significant intersessional effort that Emily, Rhea and Heather, along with all CMS-IWG participants, have put into this work and I am committed to ensuring that these groups have the best opportunity to complete their work and present this to TCC18. Please be assured that no simultaneous working groups will be scheduled.

Heads of Delegations Meeting

As per usual practice, a Heads of Delegations meeting will be convened the afternoon prior to TCC18, to be held from 4pm Tuesday 20 September Pohnpei time. An agenda for this meeting will be provided in due course.

Revised TCC18 Provisional Agenda

Please note that a revised TCC18 Provisional Agenda has been posted to the TCC18 meeting page (<u>WCPFC-TCC18-2022-02 rev1</u>) – the only change from the version circulated previously is the addition of agenda item 9.4 (Election of Officers).

Commencement of the TCC18 Online Discussion Forum

The TCC18 Online Discussion Forum (ODF) will commence one month before TCC18 (Monday 22 August 2022) and will provide an important platform for preparatory and supplementary work that will enable us to best utilise the limited time available in the Zoom plenary. A list of TCC18 ODF topics will be provided prior to commencement of the forum, but in summary:

- The regular reports that the Secretariat prepares (including the Executive Director's Annual Report) will be included in the ODF with issues to be raised to plenary by exception only.
- Consideration of Cooperating Non-Member (CNM) applications will be undertaken through the ODF and reported to plenary.
- Delegation papers or proposals may be considered through the ODF.

As with last year, there will be opportunity for plenary discussion of ODF items where necessary under relevant agenda items. The TCC18 ODF will remain open through the TCC18 meeting to facilitate meeting discussions.

Other issues

I take this opportunity to remind CCMs to please provide any delegation papers/proposals and or requests for additional ODF topics by **Sunday 21 August 2022**. I also remind CCMs that I would welcome nominations for a chair for the CNM-SWG.

Participants are encouraged to register early for TCC18 Meeting and reminded that access to the ODF is limited to registered and approved TCC18 participants. You may register for the online TCC18 meeting at the following link: https://meetings.wcpfc.int/meetings/tcc18

I look forward to working with all of you in the weeks ahead towards a productive and successful TCC18 meeting. I hope that you are all staying safe and well in your countries and I welcome the advice that we will soon be able to meet in person for the WCPFC19.
