## New Zealand Report on CMM 02-2020 Conservation and Management Measure for Pacific Bluefin Tuna (2021 fishing year)

Report covering required information of paragraphs 5 and 11.

Paragraph 5 CCMs shall report to the Executive Director by 31 July each year their fishing effort and =30 kg catch levels, by fishery, for the previous 3 year, accounting for all catches, including discards. The Executive Director will compile this information each year into an appropriate format for the use of the Northern Committee.

Paragraph 11. CCMs shall report to Executive Director by 31 July annually measures they used to implement paragraphs 2, 3, 4, 5, 7, 8, 10 and 13 of this CMM. CCMs shall also monitor the international trade of the products derived from **Pacific bluefin tuna** and report the results to Executive Director by 31 July annually. The Northern Committee shall annually review those reports CCMs submit pursuant to this paragraph and if necessary, advise a CCM to take an action for enhancing its compliance with this CMM

2 CCMs shall take measures necessary to ensure that (1)Total fishing effort by their vessel fishing for Pacific bluefin tuna in the area north of the 20° N shall stay below the 2002–2004 annual average levels	New Zealand vessels do not fish north of 20°N.
<b>2 (2)</b> All catches of Pacific bluefin tuna <b>less than30kg shall be</b> <b>reduced to 50% of the 2002–2004</b> annual average levels Any overage or underage of the catch limit shall be deducted from or may be added to the catch limit for the following year. The maximum underage that a CCM may carry over in any given year shall not exceed 5% of its annual initial catch limit.	During the 2021 fishing year no catch of Pacific Bluefin Tuna less than 30kg were caught as reported by Observers and Fishing vessels. <u>Note: For the 2021 fishing year observer data submitted to WCPFC</u> <u>incorrectly recorded 1 TOR as weighing less than 30kg. New Zealand has</u> <u>investigated this data and has found that the weight recorded was</u> <u>erroneous.</u>
<b>3</b> – CCMs shall take measures necessary to ensure that all catches of Pacific Bluefin tuna <b>30kg or larger shall not be increased from</b> <b>the 2002-2004 annual average levels</b> . <sub>2</sub> Any overage or underage of the catch limit shall be deducted from or may be added to the catch limit for the following year. The maximum underage that a CCM may carry over in any given year shall not exceed 5% of its	Average catches of Pacific Bluefin tuna by New Zealand fishing vessels for the fishing years 2002 to 2004 was 53.76 tonnes. During the 2021 fishing year a total of 36.78 tonnes of pacific blue fin above 30kg - below the average catches as described above.

annual initial catch limit <sup>1</sup> . However, in 2021 CCMs may use part of the catch limit for Pacific bluefin tuna smaller than 30 kg stipulated in paragraph 2 (2) above to catch Pacific bluefin tuna 30 kg or larger in the same year. In this case, the amount of catch30 kg or larger shall be counted against the catch limit for Pacific bluefin tuna smaller than 30 kg. CCMs shall not use the catch limit for Pacific bluefin tuna 30 kg or larger to catch Pacific bluefin tuna smaller than 30 kg. The ISC is requested to review, in its work referred to in Section 5 of Harvest Strategy, the implications of this special provision in terms of PBF mortality and stock rebuilding probabilities in 2021. Based on that review, in 2021 the Northern Committee will determine whether it should be continued past 2021, and if so, recommend changes to the CMM as appropriate.
