UPDATED PROVISIONAL LIST OF TOPICS FOR THE TCC18 ONLINE DISCUSSION FORUM

WCPFC-TCC18-2022-ODF¹ 21 September 2022

The TCC18 Online Discussion Forum (ODF) facility will provide an important platform for preparatory and supplementary work that will enable TCC participants to best utilise the limited time available in the Zoom plenary. Hence, the ODF will include both:

- The regular reports that the Secretariat prepares (including the Executive Director's Annual Report) with priority issues to be raised to plenary only if needed.
- Consideration of Cooperating Non-Member (CNM) applications with the outcomes reported to plenary.
- Delegation papers or proposals may also be considered through the ODF.

As with last year, there will be opportunity for plenary discussion of ODF items where necessary under relevant agenda items. The TCC18 ODF will remain open through the TCC18 meeting to facilitate meeting discussions.

The table below includes the list of agenda items from the TCC18 Provisional Agenda that are earmarked for discussion at the ODF facility that supplements the Zoom online plenary of the electronic TCC18 meeting. The list includes some agenda items identified in TCC18 Provisional Agenda for consideration through the ODF, with papers to be taken as read and these papers will not be presented at the plenary. The table also includes agenda items that are placed on the ODF to initiate preliminary discussion and exchange of views, but their full consideration and discussion would still be held at plenary.

CCMs with delegation papers for the TCC18 meeting may indicate to the Secretariat their wish to have their delegation paper also placed on the ODF to initiate preliminary discussion but the CCM concerned will be responsible for facilitating those preliminary discussions (*). CCMs were requested to provide delegation papers/proposals and/or requests for additional ODF topics at least 30 days ahead of the meeting, i.e. by **Sunday 21 August 2022**.

The ODF commenced on **Monday 22 August 2022.** The TCC18 ODF will remain open through the TCC18 meeting to facilitate meeting discussions. The forum topics have been tentatively
