

COMMISSION Twentieth Regular Session 4-8 December 2023 Rarotonga, Cook Islands (Hybrid) WCPFC FADMO-IWG Work Plan 2022 - 2023

- 1. The WCPFC19 supported the SC18 and TCC18 recommendations for the IATTC definition of biodegradable and categories of biodegradable FADs. The Commission further tasked the FADMO-IWG with assistance from the Secretariat and the Scientific Services Provider to review the effectiveness of paragraph 22 of CMM 2021-01 and other FAD-related issues and incorporate them into its 2023 work plan.
- The FADMO-IWG Chair initiated identifying priority tasks of the FADMO-IWG and was informed through WCPFC Circular 2023/12 with an updated work plan for 2023 (refer to Attachment A below).
