## Views of 17 Organizations of Japan that Support Sustainable Production and Consumption of Tropical Tunas

## Dear Japanese Delegates and Dr Josie Tamate WCPFC chair

We, the undersigned 17 organizations of Japan which support sustainable production and consumption of tropical tunas (Yellowfin and Bigeye tunas), request that the annual session of the WCPFC starting on December 4, 2023, implement Harvest Strategies in accordance with a precautionary approach for sustainable use and conservation of the tropical tunas' stock.

The catch of tropical tunas in the western and central Pacific has been increasing, and accordingly, the stock has declined significantly over the past 50 years. If this situation continues, both the global fishing industry that depends on tropical tunas and a healthy ocean ecosystem will be at risk.

In order to resolve the above situation, we request that WCPFC urgently develop and implement a precautionary harvest strategy approach that includes limit & target reference points, harvest control rules and other elements for tropical tunas in the WCPO.

Tropical tunas are harvested in huge quantities around the globe, and the WCPO represents the largest fishery in the world. Adaptation of the Conservation and Management Measures (CMMs) suggested above will lead the promotion of sustainable tuna fisheries around the world. We expect the WCPFC will make responsible decisions, as achieving these goals at the WCPFC will secure the future of the WCPO tropical tuna stocks and also encourage sustainable fisheries management globally.

Japan is one of the world's leading fishing and consuming countries for tropical tunas. In order to implement a precautionary harvest strategy approach, we expect the Japanese delegations will take a leadership role in the WCPFC.
