# Progress report on the West Pacific East Asia Oceanic Fisheries Project WCPFC-SC6-2010/WPEA-PSC2/GN-IP-10 (rev 1)

Prepared by the Secretariat

### I. Introduction

The WPEA project was designed to address data gaps in the WCPO tuna fishery, to reform policy, legal and institutional arrangements according to WCPFC requirements. The Global Environment Facility (GEF) has committed to providing USD\$925,000 to the WPEA. GEF support would not have been possible without the formal involvement of several significant project partners. In addition to in-kind and cash contributions by the participating countries (Indonesia, Philippines and Vietnam), the Project had secured co-financing or funding in-kind partnership arrangements with the Australian International Development Assistance Agency (AusAID), the US National Marine Fisheries Service, the Government of Japan (though the WCPFC Japan Trust Fund), the Pacific Islands Forum Fisheries Agency (FFA), the Australian Centre for International Agriculture Research (ACIAR) and the WCPFC. This report is a brief summary on the progress of the WPEA project.

#### II. Summary of WPEA Activities

Prior to the WPEA Project, was the Indonesia and Philippines Data Collection Project (IPDCP) which began in the Philippines in 2005, where port sampling and catch and effort data compilation activities were carried out. All tuna fisheries data from this project was incorporated into the WCPFC data holdings. Indonesia initiated the IPDCP in January 2007 by convening the first Eastern Indonesia Tuna Fishery Data Collection Workshop.

The first official WPEA project activity was the Inception Workshop held in Cebu, Philippines, 3-4 July 2009, with Project representatives from Indonesia, Philippines and Vietnam. Vietnam convened its national WPEA Inception Workshop in Hanoi, late 2009, to ensure its stakeholders understood the purpose and expected outcomes of the Project. The WPEA Project Document was signed by the three countries on 6 January 2010, which became the official start date of the WPEA Project.

After lengthy consultations with each of the individual countries, the WCPFC Secretariat submitted WPEA annual work plans (AWPs) and budget implications to UNOPS and UNDP in early January 2010 for their review. Key components include data collection of tuna fishery catches, and review and possible reform of national fisheries legislation, policy and institutional arrangements. Recently, the co-executing agency (UN Office for Project Services) informed WCPFC that the UNOPS Contract's Committee had accepted the WPEA AWP and Budget and awarded a contract to WCPFC for USD\$855,944 (after deduction of the UNOPS management fee).

During the first and second quarter of 2010, the three countries conducted workshops covering the implementation of new port sampling programmes, review of existing port sampling activities, the training of enumerators, and stakeholder awareness. in relation to data collection activities. In the case of Indonesia, the WPEA Data Manager (Research Centre for Capture Fisheries) visited SPC-OFP to attend a one-week database training course. Indonesia also convened the First Eastern Indonesia Tuna Fishery Annual Catch Estimates Review Meeting as one of their AWP activities. In Vietnam, a field trip was conducted to the three key provincial tuna landing sites, to determine whether data collection at these sites was feasible, with Vietnam's first Port Sampling Workshop also held in March, port sampling programme have been conducted in one province of Vietnam. In addition, a legal, policy and institutional workshop was also convened in June. Both three countries were invited to SPC-OFP for the Tuna Data Workshop and Stock Assessment Workshop to improve their capacity in tuna data management and understanding of the stock assessment for the western and central Pacific tuna stocks.

The key WPEA activities are compiled in Table 1 below, with budget including co-financing.
