DRAFT IUU VESSEL LIST AND CURRENT WCPFC IUU VESSEL LIST

Introduction

- 1. The Fourth Regular Session of the Commission (WCPFC4) adopted Conservation and Management Measure-2007-03 (CMM-2007-03) 'Conservation and Management Measure to Establish a List of Vessels Presumed to Have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO'. CMM-2007-03 requires the Executive Director to prepare a draft IUU Vessel List based on information received from Members, Cooperating Non-Members and Participating Territories (CCMs) at least 120 days before the annual meeting of the Technical and Compliance Committee (TCC). CMM-2007-03 further requires the Executive Director to transmit the draft IUU Vessel List, together with all the supporting evidence provided, to all CCMs, as well as to non-CCMs with vessels on the list, at least 90 days before the annual meeting of the TCC.
- 2. On 1 July 2008 the Executive Director dispatched to CCMs a draft IUU Vessel List and supporting evidence that was prepared by the Secretariat, on the basis of information provided by CCMs, pursuant to CMM-2007-03. This draft list was also dispatched to those non-CCMs with vessels on the draft list. At the same time, the Executive Director transmitted to CCMs and the non-CCMs concerned the WCPFC IUU Vessel List adopted during 2007, as well as new, suitably documented information regarding this list.

Draft IUU Vessel List

- 3. In accordance with CMM-2007-03, CCMs and non-CCMs transmitted, at least 30 days before the annual meeting of the TCC, their comments to the Executive Director, including suitably documented information showing that the vessels have fished in a manner consistent with WCPFC conservation measures or the laws and regulations of a State when fishing in the waters under the jurisdiction of that State, or have fished exclusively for species not covered by the WCPFC Convention. As of the date of preparation of this paper the Executive Director had not received comments from Ecuador, Panama, Georgia and Indonesia in respect of their flag vessels on the draft IUU Vessel List.
- 4. Using this information, the Executive Director drew up a draft IUU Vessel List (**Attachment 1**) and re-circulated it on 15 September 2008, together with all the suitably documented information, to the CCMs and non-CCMs concerned. At the same time, the Executive Director circulated the current WCPFC IUU Vessel List (**Attachment 2**), including

suitably documented information, to the CCMs and non-CCMs concerned. As of the date of preparation of this paper the Executive Director had not received comments from Venezuela in respect of its flag vessels on the WCPFC IUU Vessel List.

Provisional IUU Vessel List and current WCPFC IUU Vessel List

- 5. Pursuant to CMM-2007-03, TCC4 is invited to:
- a. following consideration of the draft IUU Vessel List, and suitably documented information circulated by the Executive Director, adopt a Provisional IUU Vessel List, and submit it to the Commission for consideration and approval;
- b. as appropriate, recommend any proposed changes to the current WCPFC IUU Vessel List; and
- c. consider the relationship between a CCM's record of fishing vessels and authorization to fish, the WCPFC Record of Fishing Vessels and the WCPFC IUU Vessel List. In respect of this it is noted that it is currently possible for a vessel to be listed on both the WCPFC Record of Fishing Vessels and the WCPFC IUU Vessel List.
