IWG-ROP was reactivated in 2023



- WCPFC19 Commission supported TCC's recommendation to reactivate the IWG-ROP to:
 - Provide advice to assist in Commission discussions,
 - Ensure the ROP optimizes its contribution to the Commission's independent monitoring and verification programs, and
 - Support achieving the Commission's objectives for the ROP as set out in the Convention
- IWG-ROP workplan for 2023-2025 was prepared from the Terms of Reference, and TCC18 and WCPFC19 taskings

IWG-ROP Workplan Themes

2023-2025

There are four themes for tasks in the Workplan:

1. Review and recommend draft modifications to ROP Minimum Data Fields

- Consider removal of redundant ROP data fields to streamline
- Review Observer data fields to improve data collection for Species of Special Interest,
 - Cetaceans and whale sharks distinguish between interactions and infractions
 - Sea turtles and seabirds allow for use in compliance case files
 - Advice on training and implementation needs
- Review transhipment observer data fields

2. Review and consider ROP observer coverage

 Includes advising on the potential to increase observer coverage and alternative means to collect data

3. Standards for ROP Observers

Includes advising on observer safety matters

4. Considerations related to emerging technology

Includes advising on ER and EM opportunities to streamline observer work
