REVIEW OF STATUS OF MEASURES

WCPFC-TCC2-2006/07(Rev.2) 20 September 2006

Paper prepared by the Secretariat

Introduction

- 1. Article 14(1) of the Convention describes the functions of the Technical and Compliance Committee (TCC). These functions include the provision to the Commission of information, technical advice and recommendations relating to the implementation of, and compliance with, conservation and management measures.
- 2. The process of monitoring and reporting on measures adopted by the Commission commenced in July 2005 when the Chair circulated a letter to Members requesting information detailed in Annex I of the Final Report of Working Group III that has been retrospectively developed into Conservation and Management Measure-2004-01, 'Record of Fishing Vessels and Authorization to Fish'.
- 3. The Commission's Conservation and Management Measures that apply equally to Members, Cooperating Non-Members and Participating Territories (CCMs) are listed in **Table 1**. Several of these measures impose reporting and monitoring obligations on CCMs.

Record of Fishing Vessels and Authorization to Fish

- 4. Under this measure, each CCM was required to submit to the Executive Director by 1 July 2005 particular information with respect to each vessel listed in its national record of fishing vessels entitled to fly its flag and authorized to fish in the Convention Area beyond its area of national jurisdiction. After 1 July 2005, each CCM is required to notify the Executive Director within 15 days, or in any case within 72 hours before commencement of fishing activities in the Convention Area by the vessel concerned of:
 - a. any vessel added to its Record along with the information set forth in paragraph 5 of Conservation and Management Measure-2004-01;
 - b. any change in the information referred to in paragraph 5 with respect to any vessel on its record; and
 - c. any vessel deleted from its record along with the reason for such deletion in accordance with Article 24 (6) of the Convention.

5. At the time of preparing this paper, 17 CCMs had provided records of their respective fishing vessels, as listed in **Table 2**.

6. A summary of the information provided by CCMs is presented in Table 3. Vessel details were submitted as MS Excel and pdf files in a range of formats. Because of file transfer difficulties not all respondents were able to submit colour photographs of vessels as stipulated in paragraph 5(g) of Conservation and Management Measure-2004-01.

Authorizations to Fish

- 7. As reported to TCC1, some CCMs have assigned a number for the WCPFC Identification Number (WIN) while others have not. Some CCMs used an alphanumeric identifier for the WIN while others simply provided a number.
- 8. In addition to the WIN, China refers to an 'Authorization Number', Chinese Taipei (Authorization Form), New Zealand (High Seas Permit), and United States of America (High Seas Fishing Permit). Korea issues authorizations for a period of five (5) years, includes an 'Authorization Number', but makes no reference to a WIN.

- 9. The validity of authorizations from the majority of CCMs that provided this information is 12 months. In the case of Korea and the United States of America, the authorization is valid for five (5) years and for China, validations range from 12 months to two (2), five (5) and six (6) years. In some cases the period of validity is not specified. In relation to those authorizations that expired after 12 months, the Commission has not been advised as to whether or not these authorizations have been renewed.
- 10. Some CCMs provided information on the fishing areas in which vessels are authorized to operate. However, because several CCMs authorize vessels to fish on the high seas globally, the WCPFC Record of Fishing Vessels is not a good indicator of active fishing capacity in the WCPO because it may include vessels that have never operated, or never plan to operate, in the WCPO. To address this issue, CCMs may wish to consider the addition of an 'active/inactive vessel in the Convention Area' status in respect of each fishing vessel entered in the record required to be maintained under Article 24 (4).
- 11. While some respondents provided information on species and time periods for which the authorizations were valid, there was little or no evidence that the other authorization requirements were satisfied (paragraph 3, Conservation and Management Measure-2004-01). These requirements include:
 - a. permitted activities by the vessel;
 - b. a prohibition of fishing, retention on board, transshipment or landing by the vessel in areas under the national jurisdiction of an other State except pursuant to any license, permit or authorization that may be required by such other State;
 - c. the requirement that the vessel keep on board the authorization issued; and
 - d. any other specific conditions to give effect to the provisions of the Convention, and conservation and management measures adopted pursuant to it.

CCMs Records of Fishing Vessels

- 12. A total of 5,118 vessels are included in the records submitted to the Executive Director by CCMs since 1 July 2005. These cover small, medium and large-scale tuna fishing vessels (Table 3), vessels targeting tuna and other species, support vessels, and research and training vessels.
- 13. While it has not been possible to verify the information contained in each CCMs Record, it is clear that not all the information required in Conservation and Management Measure-2004-01 has been provided by all of those CCMs that submitted vessel records. During 2006 the Commission Secretariat worked collaboratively with several CCMs to remedy deficiencies in their respective vessel records.
- 14. In accordance with a TCC1 recommendation regarding the need to standardize certain technical aspects of the information to be submitted (e.g. the metric on carrying capacity), on 11 July 2006 the Executive Director wrote to CCMs seeking comments on a draft template being developed by the Commission Secretariat to assist CCMs to collect this information. Japan, Fiji and New Caledonia provided comments on this draft template.

WCPFC Record of Fishing Vessels

- 15. As a result of the Executive Director's international request in early 2006 for expressions of interest in developing a database for the WCPFC Record of Fishing Vessels, a locally-based company was contracted to develop a database to contain fishing vessel records provided by CCMs that can be readily amended in accordance with notifications of changes and deletions by CCMs. This database has been designed so that its contents can be readily:
 - a. made available through the WCPFC website;

- b. serve as a template for the provision of vessel information by CCMs; and
- c. summarized for annual circulation to CCMs.
- 16. Since each CCM supplies its vessel record information in different formats, it is suggested that each CCM be provided with a 'CCM Version' of the WCPFC Record of Fishing Vessels database that will:
 - a. assist each CCM's vessel registration staff to assemble the information in a standard format 'at source'; and
 - b. eliminate the need for Commission Secretariat staff to re-order the information following its submission by respective CCMs.

Conservation and Management Measures for Bigeye and Yellowfin Tuna in the Western and Central Pacific Ocean

17. Conservation and Management Measure-2005-01 requires in a footnote that "Current level of fishing effort shall include fishing rights authorized under existing regional or bilateral fisheries partnership arrangements or agreements, provided these are registered with the Commission, and provided that the number of licences authorized under such arrangements does not increase. CCMs will register their bilateral agreements or arrangements with the Commission in advance of the Third Session of the Commission in 2006."

18. At the time of writing this paper, the Commission Secretariat has received information from three CCMs¹ on existing regional or bilateral fisheries partnership arrangements or agreements. To assist CCMs to comply with their obligations in this respect, the Commission Secretariat has developed a brief form (**Attachment 1**).

Conservation and Management Measures for North Pacific Albacore

- 19. Conservation and Management Measure-2005-03 states that all CCM shall report:
- a. all catches of North Pacific albacore to the WCPFC every six months, except for small coastal fisheries which shall be reported on an annual basis. Such data shall be reported to the Commission as soon as possible and no later than one year after the end of the period covered; and
- b. annually to the WCPFC all catches of albacore north of the equator and all fishing effort north of the equator in fisheries directed at albacore. The reports for both catch and fishing effort shall be made by gear type. Catches shall be reported in terms of weight. Fishing effort shall be reported in terms of the most relevant measures for a given gear type, including at a minimum for all gear types, the number of vessel-days fished. First report due on April 30, 2006 and shall cover calendar year 2004.
- 20. At the time of writing of this paper the Commission Secretariat has received:
 - a. six-monthly reports of all catches of North Pacific albacore from Canada (2005), Chinese Taipei (2002-2005), United States of America (2004-2005), Vaunatu (2004-2005); and

- b. reports of estimated catches of North Pacific albacore for 2005 as follows:
 - i. Canada troll;
 - ii. Japan offshore and distant-water purse seine;
 - iii. Korea longline;
 - iv. Chinese Taipei distant-water longline;
 - v. Chinese Taipei offshore longline;
 - vi. U.S.A. distant-water troll, gill net, troll and handline, longline, poleand-line, purse seine, and sports and unclassified;
 - vii. Vanuatu large-scale longline.

Annual report to the Commission

- 21. At TCC1 CCM agreed to provide an Annual Report to the Commission, the purpose of which is to report relevant information to the Commission on their respective fishing activities during the preceding calendar year, and management and compliance issues during the present year. Part 1 of this report relating to information on fisheries, research and statistics was to have been submitted by 30 June 2006 or one month before the second regular session of the Scientific Committee (SC2). The Commission Secretariat has now received Part 1 reports from all CCM.
- 22. Part 2 of this report relating to management and compliance is to be submitted one month before the regular session of the Commission, or TCC2, combined with Part 1 of the Annual Report. CCM have agreed to provide in Part 2 of their Annual Report to the Commission:
- a. information on inspections undertaken in their respective ports and any violations detected; and
- b. a report on steps taken to implement Resolution-2005-04 'Resolution to mitigate the impact of fishing for highly migratory fish species on sea turtles.
- 23. Preparation of the Annual Report provides an ideal opportunity for CCM to report progress on the following issues:
 - a. Resolution-2005-01 'Resolution on the Incidental Catch of Seabirds' (CCM shall report to the Commission on their implementation of the IPOA-Seabirds, including, as appropriate, the status of their National Plans of Action for Reducing Incidental Catches of Seabirds in Longline Fisheries);
 - b. Resolution-2005-02 'Resolution on the Reduction of Overcapacity' (Chinese Taipei has made a commitment to cooperate with Japan and other concerned Members to implement the Resolution);
 - c. Resolution-2005-04 'Resolution to Mitigate the Impact of Fishing for Highly Migratory Fish Species on Sea Turtles' (Beginning in 2006, CCM shall include in their Annual Report to the Commission [Part 2] a report on the steps taken to implement this resolution);
 - d. Progress by concerned Members and Japan with the development of a comprehensive catch documentation scheme covering all catch; and
 - e. Progress by Members with efforts to exercise reasonable restraint in expanding fishing effort on the south-west Pacific swordfish stock, particularly with respect to establishing a catch history in anticipation of the adoption of conservation and management measures.

- 24. As a result of preparing their respective Annual Reports, some CCMs have advised the Commission Secretariat that there are ambiguities in some of the data fields, e.g. the start and end dates of the 'previous year' in the second paragraph of the Annual Report. CCM are invited to suggest amendments to the Annual Report form to remove these ambiguities.
- 25. To assist them in completing Part 2 of the Annual Report, CCM may wish to note an annotated version of Part 2 (**Attachment 2**) that has been prepared by the FFA Secretariat to assist FFA members in this regard.

Conclusion

- 26. It is clear that the reporting obligations associated with complying with the Convention's principles and implementing the Commission's decisions present significant challenges for all CCM, and that some CCM are experiencing difficulties complying with the current requirements. While it is not expected that this situation will decrease in the short to medium term, systems and procedures to assist CCM in complying with monitoring and reporting obligations will gradually be refined so that improved efficiency and effectiveness is achieved in this regard.
- 27. An issue that requires the Commission's near-term attention is a process to manage non-compliance. A complementary paper (WCPFC/TCC2/2006/09) has been prepared by the Secretariat to facilitate discussion on this important matter.
- 28. Developing an optimal flow of information to and from CCM and the Commission is an ongoing priority for the Commission Secretariat. To assist in this development, CCM are invited to:
 - a. use a CCM version of the WCPFC Fishing Vessel Record Database to provide vessel record information to the Commission;
 - b. add an 'active/inactive vessel in the Convention Area' status in respect of each fishing vessel entered in the record required to be maintained under Article 24 (4);
 - c. register existing regional or bilateral fisheries partnership arrangements or agreements if they have not already done so;
 - d. provide information on all catches of North Pacific albacore to the Commission every six months;
 - e. provide annually to the WCPFC all catches of albacore north of the equator and all fishing effort north of the equator in fisheries directed at albacore;
 - f. submit Part 2 of the Annual Report relating to management and compliance one month before the regular session of the Commission, or TCC2, combined with Part 1 of the Annual Report; and
 - g. provide suggested amendments to the Annual Report form to improve its utility and minimize ambiguities.

ANNUAL REPORT TO THE COMMISSION PART 2. MANAGEMENT AND COMPLIANCE

(summary information for the <u>current year</u>)

In regards to the data that Part 2 covers, this was written when the TCC met in conjunction with the Commission meeting in December, however this year the TCC will meet in late September and early October. Presumably CCMs are required to report on activities since the last Commission meeting in December 2005.

(To be submitted one month before the Regular Session of the Commission, or the TCC, combined with Part 1 of the Annual Report – Information on Fisheries, Research and Statistics) In 2006 the Management and Compliance Report should be submitted together with the 'National Fishery Report' (the two parts make up the Annual Report to the Commission) to the WCPFC Secretariat by 25th September 2006.

2.1 IMPLEMENTATION OF CONSERVATION AND MANAGEMENT MEASURES
