# DRAFT MCS PRIORITIES AND IMPLEMENTATION SCHEDULE WCPFC-TCC2-2006/23

19 September 2006

## Introduction

1. The Second Regular Session of the Commission (Comm2) in December 2005 endorsed an agreement by the First Regular Session of the Technical and Compliance Committee (TCC1) that the priority components for the elaboration of the Commission's monitoring, control and surveillance (MCS) framework for the next two (2) years are as follows:

- a. Members' and Commission's lists of fishing vessels;
- b. Vessel Monitoring System;
- c. Regional Observer Programme;
- d. Port State Scheme and transhipment;
- e. High seas Boarding and Inspection Scheme;
- f. Catch verification;
- g. Catch and Statistical Documentation Scheme; and
- h. Gear Marking.

2. The current technical and compliance elements of the Commission's Work Program are listed in **Attachment 1**, together with nominal costs for the period 2007-2011.

## Discussion

3. While some of the listed work program elements can be accomplished 'in-house' and at nominally zero cost, others are likely to require outside expertise and significant financial support. TCC2 is invited to consider its technical and compliance priorities within the Commission's MCS framework for the next five (5) years. It is also invited to advise on securing the necessary resources to support the effective implementation of a work program to achieve the objectives associated with each element of that framework.

## Conclusion

4. TCC2 is invited to review the technical and compliance elements of the Commission's Work Program and to provide advice to the Commission on its priorities, and means to support their effective implementation, for the period 2007-2011.
