Purpose

The Commission adopted CMM 2013-07 at WCPFC10 in December 2013 CMM 2013-07 identifies several priority areas related to the recognition of the special requirements of small island developing States and Territories, including capacity development, technology transfers, support for fisheries conservation and management, monitoring, control, and surveillance, support for the domestic fisheries sector, and tunafisheries related businesses and market access. Each year, CCMs are required to report through Annual Report Part 2 on their implementation of CMM 2013-07.

At WCPFC15, the Commission directed the Secretariat to develop a webpage dedicated to the <u>Implementation of Article 30 of the Convention</u> and to publish reports by CCMs on the implementation of CMM 2013-07 on the webpage.

The attached compilation contains CCM reports on implementation of CMM 2013-07 as submitted through the 2025 Annual Report Part 2, covering Reporting Year 2024. This responds to the Commission task for the Secretariat to compile this information for review by TCC.

China has long recognized the importance of developing the PICs fishing capabilities, acknowledging their desire to advance their own fisheries. We are committed to promoting fisheries cooperation between China and the Pacific Island nations. In terms of high-level China-Pacific Island fisheries cooperation, China has already hosted three China-Pacific Island Fisheries Cooperation Forums. These forums serve as a platform for cooperation with members of the Pacific Island fisheries community, fostering comprehensive exchanges and targeted development.

China has always approached and developed its relations with Pacific Island nations from the perspective of building a community with a shared future for mankind, cherishes the deep friendship established with Pacific Island nations, and is committed to providing assistance within its capacity for their economic development and livelihood improvement. In 2024, China held the "One Country One Product" Pacific Island Nations Launch Ceremony and Seminar in Nanjing, aimed at promoting agricultural development in Pacific Island nations, helping them improve comprehensive agricultural utilization, and supporting the construction of more resilient and sustainable agri-food systems. Eight Pacific Island nations showcased their specialty agricultural products. FAO representatives introduced the implementation progress and achievements of "One Country One Product" globally and in the Asia-Pacific region, while representatives from multiple countries shared their implementation experiences, challenges faced, and cooperation needs. In 2024, China continued to encourage its fishing enterprises to arrange vessels through chartering arrangement to local companies, aiding thesePICs in accumulating historical fishing data in their Exclusive Economic Zones and on the high seas. We remain dedicated to maintaining and enhancing the construction of comprehensive fisheries bases in the Pacific Islands, including maintaining ship repair yards and processing plants in the ports of these nations to advance the construction of their fisheries industry chains. China is also employing local labor working on Chinese LL fishing vessels to boost local employment rates.

As of 2024, the vast majority (approximately 70-80%) of catches by Chinese distant-water fishing fleets in the Western and Central Pacific Ocean come from Pacific Island Countries'EEZs, with only 20-30% from the high seas. Among these, purse seine vessels show the highest dependence on island nations' EEZs, with approximately 95-96% of their catches from EEZs; low-temperature longline vessels primarily targeting albacore tuna obtain about 75% of their catches from EEZs; ultra-low temperature longline vessels (only 30 vessels, accounting for one-tenth of China's total active longline fishing vessels in 2024, representing a very small proportion) have a relatively higher proportion of high seas operations, but still derive approximately 60% of their catches from EEZs. These data clearly demonstrate that Chinese distant-water fisheries operate primarily within Pacific Island nations' jurisdictional waters in full legal compliance, fully respecting coastal states' sovereign rights, and making positive contributions to the economic development of island nations.

Wallis and Futuna islands tuna development plan for the next 5 years is targetting a single middle-size longliner for the domestic market. So as to inform a more robust viability analysis, a short experimental tuna fishing campaign is expected to be implemented in the short term. However, the search for a partner in the region to implement it has not been successfull so far: 2 companies have been reached out for a time charter arrangement but both offered chartering conditions that were considered too risky if not unaffordable. One of them has dismissed a proposal for a fishing license including requirement to offload in Wallis and commitment from local authorities to contract a buyer for the fish with an agreed price.

In that context, assistance needs from CCMs and regional organisations (SPC and WCPFC) for capacity building relate to:

- helping design terms of reference for the chartering arrangement
- helping find a company who would make a vessel and skilled crew available for 3 months within affordable day fee
- providing observer(s) to cover one trip out of 2 or 3

Australia provides core funding to the Pacific Islands Forum Fisheries Agency (FFA) (AUD5 million per year) to support effective and strengthened cooperative management of the region's tuna resources, including fisheries management and development, and monitoring, control and surveillance. Australia also provides program funding to the Fisheries, Aquaculture and Marine Ecosystems Division (FAME) of the Pacific Community (AUD3 million per year for its fisheries division) to provide scientific information and support for fisheries management.

Australia is providing an additional AUD5 million per annum to support strengthened FFA and regional MCS activities, including capacity development of personnel of SIDS and Territories. Australia provides direct fisheries capacity building for SIDS to support national MCS capacity including supporting the annual FFA and SPC MCS Officers Foundation course. Australia has provided approximately AUD1 million to the Solomon Islands National University and the Australian National Centre for Ocean Resources and Security (ANCORS) at the University of Wollongong, to co-develop and deliver a Graduate Certificate in Pacific Fisheries Governance that provides a foundation qualification for Pacific fisheries managers and officials and build expertise and knowledge in fisheries management, development and governance.

To fulfill our obligations, China has consistently welcomed students from Pacific Island nations to study in China through the China-Pacific Island Countries Forum and various scholarship programs. These students are encouraged to pursue studies in marine biology, fisheries resources, and other related fields at institutions such as Shanghai Ocean University, where scholarships are specifically available to support.

In 2024, Shanghai Ocean University and Shanghai Normal University jointly cultivated international students from Fiji, Vanuatu, and Tonga. In the same year, the China-Pacific Island Countries Dialogue on Climate Change Response was successfully held in Liaocheng, Shandong Province, focusing on cooperation achievements and future collaboration prospects in green energy, low-carbon development, and low-carbon economy, promoting a closer partnership between China and Pacific Island Countries in addressing climate change. Wuyi University welcomed its first cohort of 15 international students from Fiji, Solomon Islands, and Papua New Guinea, majoring in Communication Engineering (Emergency Communication and Emergency Command), cultivating disaster management professionals for Pacific Island Countries and better advancing the construction of the China-Pacific Island Countries Disaster Prevention and Mitigation Cooperation Center. The Chinese government has established the Chinese Government Scholarship Pacific Islands Forum (PIF) Program, a full scholarship provided by the Chinese government in cooperation with the Pacific Islands Forum to fund students from Pacific Island Countries. The program aims to encourage and support young students from Pacific Island Countries to study and conduct research in China.

The PMSP provides Australian Government funded capabilities to Pacific nations as sovereign assets to enhance their capacity to provide protection and surveillance of their own resources. The PMSP includes gifting 21 Guardian-class Patrol Boats, long-term commitment to sustainment and training, and contracted civilian aerial surveillance at an overall program cost of AUD2.1 billion over 30 years. The aerial surveillance program and associated regional coordination components are contributing to improving maritime domain awareness and interoperability. The implementation of the PMSP is making a significant contribution to developing the capacity of SIDS to manage and conserve fisheries resources, including through supporting the regional implementation of the Niue Treaty Subsidiary Agreement.

China's development cooperation with the South Pacific region has been steadily advancing. China's cooperation with South Pacific Island nations is open and transparent, fully respects each country's sovereignty and will, imposes no political conditions, does not target any third party, and has been welcomed and recognized by Pacific Island governments and peoples. China's cooperation with Pacific Island nations is based on their needs. Since establishing diplomatic relations with South Pacific Island nations, cooperation platforms have continuously improved and cooperation intensity has continuously strengthened. Based on partnerships with South Pacific Island nations, China continues to advance deep cooperation at political and economic levels. To further expand development cooperation with South Pacific Island nations, one approach is to leverage key partner countries and utilize China's advantages in areas such as infrastructure construction to enhance development assistance effectiveness. China's assistance to South Pacific Island nations focuses primarily on infrastructure construction, addressing the critical challenges of inadequate transportation infrastructure and limited economic and trade corridors. China's construction of Samoa International Airport and airports and roads in Papua New Guinea has effectively promoted regional cooperation and development among South Pacific Island nations. Future cooperation can build upon infrastructure construction with supporting capacity-building initiatives including maintenance and training, while simultaneously enhancing infrastructure resilience to climate change. Currently, China cooperates with South Pacific Island nations in six major areas: infrastructure construction, poverty reduction, climate change, disaster prevention, agriculture and fisheries, and Juncao technology. China has not yet received any intentions from Pacific Island nations regarding joint fisheries enforcement or strengthening fisheries supervision cooperation. However, China requires that vessels fishing in EEZs and chartered vessels strictly comply with local national laws and regulations. Through the People's Republic of China's Distant Water Fisheries Management Regulations, Fishing License Management Regulations, and WCPFC compliance requirements, among other laws, regulations, and departmental rules, China implements strict compliance requirements for vessels fishing in EEZs and chartered vessels, which also alleviates fisheries supervision pressure on Pacific Island nations and assists Pacific Island fisheries authorities in managing fisheries within their EEZs.

The National Monitoring Control Committee (MCC), includes the Port Authority, Ministry of Fisheries, Marine Department, Police Department, Customs Department, and the Navy. The MCC Centre is established by the committee and is housed at Navy Station. MCC conducts a national monitoring within our EEZ once per quarter. Aerial surveillance was provided by FFA in all quarters during the reporting period, and no offenses were reported. The New Zealand Government has a bilateral agreement with Tonga on Aerial Surveillance during the Tuimoana Operation through the NTSA System. During the reporting period, Tonga participated in SPC/FFA regional training for observers, observers refresh training, and newly recruited 10 observers on board, SPC conducted biosampling training with observers and staff. Few staff join Certificate IV on Coastal and Aquaculture, Diploma on Investigation and Prosecution Cert, Certificate Level IV on Fisheries Enforcement and Compliance, and Law of the Seas Courses. SPC also conducted training on e-reporting basically for data collection through OLLO, Onboard, and onshore, TAILS, and Close Kin Mark Recapture Sampling training, and SPC also conducted training the Science Division on stock assessment for sea cucumbers. FFA financially supported Tonga in conducting the e-PSM training and Tonga was the first country to implement the e-PSM, Dockside Boarding, NTSA training, and Aerial Surveillance Training. If we conducted the Monitoring Control and Surveillance and detected an offense, the Fisheries Management Act 2002, Section 19, sub-section (5) "shall be guilty of an offense and shall be liable on conviction to a fine not exceeding \$25,000". Tonga has a Standard procedure for infringement and is taken up to Court.

The U.S. Coast Guard worked closely with partner nations including Cook Islands, the Federated States of Micronesia, Fiji, Kiribati, Nauru, Republic of the Marshall Islands, Palau, Papua New Guinea, Samoa, Tonga, Tuvalu, Vanuatu, Australia, France, and New Zealand to deter IUU fishing through patrols and joint maritime domain awareness efforts. In 2024, U.S. Coast Guard supported four Pacific Islands Forum Fisheries Agency (FFA) Operations including Rai Balang, Kuru Kuru, Island Chief and Tui Moana with surface and air maritime security presence to counter IUU fishing. Operation Rai Balang resulted in sighting 14 vessels of interest. The U.S. Coast Guard supported Operation Nasse 2024, an annual multilateral monitoring, control and surveillance (MCS) activity, that targets IUU fishing in the Western Central Pacific Ocean on the high seas. During the operation, U.S. Coast Guard aircraft conducted five sorties and sighted 28 fishing vessels, of which, one was fishing on the high seas and not broadcasting on VMS and two did not have tori lines. The U.S. Coast Guard participated in Operation North Pacific Guard 2024, an annual multi-mission effort between U.S. Coast Guard, NOAA, Canada and international partners focused on countering IUU fishing in the North Pacific to protect global fish stocks. U.S. Coast Guard aircraft and crew completed five 12-day deployments and observed 411 vessels across WCPFC and NPFC conventions resulting in multiple vessels of interest. Additionally, a U.S. Coast Guard cutter completed HSBIs. In 2024, U.S. Coast Guard cutters enacted bilateral agreements with Cook Islands, the Federated States of Micronesia, Fiji, Kiribati, Nauru, Republic of the Marshall Islands, Palau, Papua New Guinea (PNG), Samoa, Tonga, Tuvalu, Vanuatu to support patrolling of their exclusive economic zones and completed 70 bilateral shiprider boardings (42 on fishing vessels and 28 on sailing vessels) comprising of 04 with Cook Islands, 35 with Fiji, 02 with Kiribati, 04 with Palau, 03 with RMI, 05 with Samoa, 05 with PNG, and 12 with Vanuatu. In 2024, at the request of the Republic of Palau and in response to concerns of potential illicit maritime activity occurring in Palau's EEZ, a U.S. Coast Guard HC-130 Hercules and aircrew embarked Palauan enforcement officials and U.S. Coast Guard specialists to patrol over 6,000 miles, identifying numerous illegal fish aggregation devices (FADs) and sighting vessels in and around Palau's EEZ. U.S. Coast Guard completed Operation Rematau 2024 to support security, safety, sovereignty, and economic prosperity in Oceania with a patrol by USCGC Frederick Hatch (WPC 1143). The Frederick Hatch responded to a request from the government of Yap for U.S. Coast Guard presence near Ngulu Atoll to deter illegal sea cucumber poaching. The crew transported 1,500 lbs. of non-perishable food, 1,200 lbs. of water, and essential supplies including fishing gear and tools to Ulithi Atoll, FSM, during a state-declared emergency drought. U.S. Coast Guard Law Enforcement Officers supported the Oceania Maritime Security Initiative (OMSI) program, a Secretary of Defense program leveraging Department of Defense assets transiting the region to increase the Coast Guard's maritime domain awareness, ultimately supporting its maritime law

enforcement operations in Oceania. In 2024, U.S. Coast Guard hosted Pacific Island bilateral partners at a week-long Shiprider Symposium share best practices, discuss regional concerns, exchange information among subject matter experts, and foster collaboration and understanding among participating nations. Overall, the United States dedicated approximately 7303.5 surface and

824.2 aerial hours on surveillance activities in areas beyond our national jurisdiction in support of IUU fishing activities during 2024. This effort equates to over 305 sea patrol days and 109 individual aerial surveillance flights.

The Australian Centre for International Agricultural Research (ACIAR) is implementing the third phase of a Community Based Fisheries Management initiative to promote the sustainable use of coastal resources. This is a DFAT-funded AUD10 million (including AUD2 million from ACIAR) project over four years (2021-25) with the aim of scaling up community-based fisheries management, aligned with implementation of the Pacific's New Song for Coastal Fisheries.

Australia has provided approximately AUD1 million to the Solomon Islands National University and the Australian National Centre for Ocean Resources and Security (ANCORS) at the University of Wollongong, to co-develop and deliver a Graduate Certificate in Pacific Fisheries Governance that provides a foundation qualification for pacific fisheries managers and officials and build expertise and knowledge in fisheries management, development and governance.

China has long recognized the importance of developing the PICs fishing capabilities, acknowledging their desire to advance their own fisheries. We are committed to promoting fisheries cooperation between China and the Pacific Island nations. In terms of high-level China-Pacific Island fisheries cooperation, China has already hosted three China-Pacific Island Fisheries Cooperation Forums. These forums serve as a platform for cooperation with members of the Pacific Island fisheries community, fostering comprehensive exchanges and targeted development.

China has always approached and developed its relations with Pacific Island nations from the perspective of building a community with a shared future for mankind, cherishes the deep friendship established with Pacific Island nations, and is committed to providing assistance within its capacity for their economic development and livelihood improvement. In 2024, China held the "One Country One Product" Pacific Island Nations Launch Ceremony and Seminar in Nanjing, aimed at promoting agricultural development in Pacific Island nations, helping them improve comprehensive agricultural utilization, and supporting the construction of more resilient and sustainable agri-food systems. Eight Pacific Island nations showcased their specialty agricultural products. FAO representatives introduced the implementation progress and achievements of "One Country One Product" globally and in the Asia-Pacific region, while representatives from multiple countries shared their implementation experiences, challenges faced, and cooperation needs. In 2024, China continued to encourage its fishing enterprises to arrange vessels through chartering arrangement to local companies, aiding thesePICs in accumulating historical fishing data in their Exclusive Economic Zones and on the high seas. We remain dedicated to maintaining and enhancing the construction of comprehensive fisheries bases in the Pacific Islands, including maintaining ship repair yards and processing plants in the ports of these nations to advance the construction of their fisheries industry chains. China is also employing local labor working on Chinese LL fishing vessels to boost local employment rates.

As of 2024, the vast majority (approximately 70-80%) of catches by Chinese distant-water fishing fleets in the Western and Central Pacific Ocean come from Pacific Island Countries'EEZs, with only 20-30% from the high seas. Among these, purse seine vessels show the highest dependence on island nations' EEZs, with approximately 95-96% of their catches from EEZs; low-temperature longline vessels primarily targeting albacore tuna obtain about 75% of their catches from EEZs; ultra-low temperature longline vessels (only 30 vessels, accounting for one-tenth of China's total active longline fishing vessels in 2024, representing a very small proportion) have a relatively higher proportion of high seas operations, but still derive approximately 60% of their catches from EEZs. These data clearly demonstrate that Chinese distant-water fisheries operate primarily within Pacific Island nations' jurisdictional waters in full legal compliance, fully respecting coastal states' sovereign rights, and making positive contributions to the economic development of island nations.

The participation of Chinese distant-water fisheries enterprises in Pacific Island nations through fishing access and chartering arrangements demonstrates high-level engagement with the region. These vessels primarily operate through fishing access or charter arrangements with 10 Pacific Island nations including Kiribati, Vanuatu, Papua New Guinea, Tuvalu, Nauru, Cook Islands, Solomon Islands, Marshall Islands, and Micronesia. In 2024, Chinese enterprises paid approximately 8.73 million RMB and 52.25 million USD in fishing access fees to Pacific Island nations, including license fees, VDS day fees, and other charges. In joint statements with Pacific Island nations, China welcomes their participation in high-quality Belt and Road cooperation, and is willing to strengthen the alignment between the Belt and Road Initiative and Pacific Island nations' development strategies, expand practical cooperation in fisheries, infrastructure, tropical agriculture, aviation and maritime transport, agricultural and fisheries processing, and green and low-carbon sectors, provide assistance within its capacity to participating Pacific Island nations in achieving independent and sustainable development, and jointly maintain the security of bilateral cooperation projects and personnel. China welcomes more specialty products from Pacific Island nations entering the Chinese market, including encouraging positive market access for new products such as fisheries products, and encourages Chinese enterprises to invest and establish businesses in Pacific Island nations, with both sides willing to provide mutual policy support and facilitation in this regard.

Ministry of Fisheries established a Development Scheme for the Fisheries Sector to improve the business climate and reduce the cost of doing business a Fishing Consumer Tax Exemption was approved in June 2013 exempting imported fishing gear, bait, and essential supplies from customs tariffs. In 2013 the operation of the Tu'imatamoana fish market and Processing Facilities was transferred under an MOU to the National Fisheries Committee (Fishing Industries Committee). In addition, the Ministry of Fisheries established a Soft Loan Scheme known Fisheries Development and Export Fund (FDEF) to support the sector market Access. Not only that but the Ministry assisted the Fishing Companies in developing and improving their business planning and management, and offered a comprehensive training and capacity development program. In 2020, Tonga ratified the PACER Plus Agreement is a Regional Development-Centre Trade Agreement designed to support Tonga in regional and Global Trade. Tonga exports fish to international markets (Australia, NZ, USA, Fiji, Pangopango, Hawaii, Taiwan, Hong Kong, and Singapore). The compliance Division inspects 100% of every export before handing the Export Permit to the companies, and entry the export data into the system and reports every quarter.
