I am pleased to submit the Provisional Agenda for the 22nd Regular Annual Session of the Commission (WCPFC22), which is scheduled to take place from Monday, December 1 to Friday, December 5, 2025, in Manila, Philippines. The Provisional Agenda was drawn up in consultation with the Commission Chair, Dr. Josie Tamate. A Provisional Annotated Agenda will be circulated in due course, along with an indicative meeting schedule.

A Meeting Notice was distributed on 9 September 2025 in Circular 2025/58, which contains information on meeting and venue arrangements, and a list of accommodation options for participants. Registration is currently available on the WCPFC22 meeting webpage.

The 19th Session of the Finance and Administration Committee (FAC19) will start on Sunday, November 30, and continue throughout WCPFC22. A Provisional Agenda and other meeting information for FAC19 will be available on the <u>FAC19 meeting webpage</u>. Participants who will attend WCPFC22 and FAC19 are reminded to register for both meetings.

In developing the WCPFC22 Provisional Agenda, the Secretariat, with support from the Commission Chair, has considered the feedback received from some CCMs at the conclusion of WCPFC21 in Suva. Consistent with Rule 2 of the WCPFC Rules of Procedure, the WCPFC22 Provisional Agenda also accommodates reporting by the WCPFC subsidiary bodies and the Commission's intersessional working groups, as well as outcomes from WCPFC21 that the Commission has indicated will be addressed at WCPFC22.

Rule 3 of the WCPFC Rules of Procedure states that CCMs may request in writing the inclusion of supplementary agenda items at least thirty days before the date fixed for the opening of the regular session, or November 1, 2025.
