SUMMARY OF PART 2 ANNUAL REPORT AND REVISED TEMPLATE FOR THE ANNUAL REPORT PART 2

Introduction

1. The Third Regular Session of the Commission (WCPFC3) endorsed a recommendation by the Second Regular Session of the Technical and Compliance Committee (TCC2) that Part 2 of the Annual Report, covering the previous calendar year be submitted to the WCPFC Secretariat by 31 July each year. The Fifth Regular Session of the Commission (WCPFC5) adopted enhanced guidelines for Part 2 submissions contained in Appendix B of WCPFC5-2008/IP07 for use in future submissions of Part 2 reports. Further, the Sixth Regular Session of the Commission Summary Report (WCPFC 6) agreed to revise the deadline for Part 2 of CCMs' Annual Reports from 31 July to one month prior to the meeting of the TCC, thus leaving only 30 days to compile the Summary Report on Compliance by CCMs for 2009. Some CCMs choose to report on the more recently amended CMMs from WCPFC6.

2. Twenty-five Commission Members, including seven Participating Territories, and seven Cooperating Non-Members were required to submit to the Commission by 31 August 2010 their respective Part 2 Reports on Management and Compliance, for the period 1 January-31 December 2009. At the time of preparation of this paper the Secretariat has received 14 Part 2 Reports which are available to TCC6. These reports were received from:

3. Since Part 2 Reports are regarded as confidential, the Secretariat has posted them in a secure "CCM Section" on the WCPFC website. TCC6 may wish to consider the information contained in this paper under TCC6 Agenda Item 2.9 (a).

Formats used in the preparation of Part 2 Reports

4. Of the 14 Part 2 Reports received by the Secretariat, all used the agreed template presented in Appendix B of WCPFC5-2008/IP07, while two of them reported their compliance with the CMMs that were updated and approved in December 2009.

Draft Template for Annual Reports Part 2

5. Paragraph 45 of CMM 2008-01 states, "All CCMs will report to each regular session of the Technical and Compliance Committee, through their Annual Report Part 2, on the implementation of this Measure for their fishing vessels operating on the high seas and/or in waters under national jurisdiction. The Technical and Compliance Committee will prepare a template for reporting this requirement for the consideration of the Commission."

6. A draft revised template for Part 2 of the Annual Reports has been developed according to the newly adopted CMMs from WCPFC6 that came into force on 9 February 2010. Members are encouraged to provide comments to the Secretariat prior to TCC6 to facilitate an amended template being presented to TCC6.

Discussion

7. Judging from the untimely submission of many of the Part 2 Reports by due date, the reporting obligations associated with complying with the Convention's principles and implementing the Commission's decisions are continuing to present significant challenges for many CCMs.

8. The Secretariat is implementing an Information Management System to assist in tracking all correspondence on CMMs received and sent out from the Secretariat. CCMs are encouraged to visit the Secretariat and get briefed on this initiative to assess if it can assist them in the compilation of their reports.

9. The Annual Report Part 2 is complex and relates directly to the reports on compliance issues or incidents encountered by Commission Members. It addresses only the compliance of CCMs with their reporting requirements, but it does not always address the actual practical compliance issues encountered by Commission Members, and actions, authorities or advice to mitigate non-compliance issues or incidents. Recognising that the actual implementation of CMMs is now revealing the practical difficulties of implementation for compliance agencies, CCMs may wish to consider and provide advice to the Commission, and subsequently to the Secretariat, on ways to make the Annual Report Part 2 more relevant to the actual compliance incidents.

Advice and Recommendations

10. TCC6 is invited to consider, advise the Commission in relation to timely submission of Annual Report Part 2 to the Commission.

11. TCC6 is invited to discuss the draft revised template for 2010 reporting requirements for both the compliance itself and further notes on its relevance to the compliance issues. Highlighted clauses are those that had not been addressed in earlier reports, or are those that are new for 2010.
