**Draft IUU Vessel List and Current WCPFC IUU Vessel List**

**Purpose**

1. This paper presents the draft IUU Vessel List for 2027 and supporting documentation, and the 2026 WCPFC IUU Vessel List for the consideration and decision of the Technical and Compliance Committee at TCC22.

**Background**

2. The Conservation and Management Measure to Establish a List of Vessels Presumed to Have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO ([CMM 2019-07](#)) requires Members, Cooperating Non-Members and Participating Territories (CCMs), at least 70 days before the annual meeting of the Technical and Compliance Committee (TCC), to transmit to the Executive Director their lists of vessels presumed to have carried out IUU fishing activities in the Convention Area during the current or previous year, accompanied by suitably documented information concerning the presumed IUU activities.
3. In addition, CMM 2019-07 requires the Executive Director to transmit the draft IUU Vessel List, together with all the supporting information provided, to all CCMs, as well as to non-CCMs with vessels on the list, at least 55 days before the annual meeting of TCC.
4. The [current WCPFC IUU Vessel List](#) for 2026 is available on the WCPFC website.

**Vessels presumed to have carried out IUU fishing activities: Draft IUU Vessel List for 2027**

5. The Secretariat received a submission from Australia on 15 July 2026 regarding vessels flagged to Indonesia that were presumed to have carried out IUU fishing activities for inclusion on the draft IUU Vessel List for 2027. Australia confirmed that, in accordance with the requirements of CMM 2019-07, it had notified Indonesia as the relevant flag State of the presumed IUU vessels, and that Indonesia confirmed receipt of the notification from Australia. The Secretariat circulated Australia's notification and supporting information on 30 July in [Circular 2026/71](#). The information submitted by Australia alleges that twenty-five (25) fishing vessels flagged to Indonesia are presumed to have carried out IUU fishing activities in the Convention Area during 2025 and 2026.

6. Accordingly, the draft IUU Vessel List for 2027 is provided in **Annex 1**. Documented information relating to the vessels on the draft IUU Vessel List for 2027 and the current WCPFC IUU Vessel List is available for authorized CCM users on the WCPFC [secure CCM IUU webpage](#).

#### Current WCPFC IUU Vessel List (2026)

7. The Commission adopted the WCPFC IUU Vessel List for 2026 at WCPFC22. The list, provided in **Annex 2<sup>1</sup>**, consists of four fishing vessels: NEPTUNE, FU LIEN No. 1, YU FONG 168, and KUDA LAUT 03.
8. On 21 January 2026, the Executive Director wrote to relevant RFMOs to request information about the vessels on the current WCPFC IUU Vessel List. No new information was received in response to these letters. Several RFMOs with cross-listing procedures have included vessels from the WCPFC IUU Vessel List on their respective IUU vessel lists.

#### Recommendations

9. TCC22 is invited to:
  - a) recommend a Provisional 2027 IUU Vessel List to the Commission for its consideration at WCPFC23.
  - b) recommend, as appropriate, any proposed changes to the current WCPFC IUU Vessel List for 2026, or make other relevant recommendations.

<sup>1</sup> **Supplementary note:** In October 2015, the Executive Director wrote to: Chinese Taipei and Georgia requesting information on their vessel/s on the WCPFC IUU list, and to other RFMOs (CCAMLR, CCSBT, IATTC, ICCAT, IOTC, NPAFC & SPRFMO) to seek their cooperation with locating the vessels on the list. Georgia confirmed that the vessels **Neptune** and **Fu Lien No 1** were no longer flying the Georgia flag. Chinese Taipei confirmed the **Yu Fong 168** license was revoked in 2009 and the vessel owner financially penalized for violating the rules of not returning to port. Chinese Taipei further advised information was received from Thailand's notification to IOTC that the vessel landed their catches in the port of Phuket in the year 2013. On 17 November 2017, Chinese Taipei informed WCPFC that the **Yu Fong 168** had been deregistered by Chinese Taipei. On 29 April 2020, WCPFC received further information from Chinese Taipei identifying the master of the **Yu Fong 168** at the time of the IUU fishing activity who had been sanctioned.
