# AGENDA ITEM 1 OPENING OF THE MEETING

The meeting will open at 08:30 on Tuesday, 10 August 2010.

#### 1.1 Welcome address

The Chair will welcome delegations of the WCPFC Members, Cooperating Non-members and Participating Territories (CCMs) and observers to the Sixth Regular Session of the Scientific Committee (SC6).

A senior official from Tonga will be invited to deliver an opening address.

# 1.2 Adoption of agenda

The Provisional Agenda for SC6 was prepared and distributed on 11 May 2010 in accordance with Rule 1 of the Commission's Rules of Procedure. Any Member of the Commission, the Chairman, or the Executive Director may, at least 30 days before the date fixed for the opening of a Regular Session request the inclusion of supplementary items in the Agenda. A request for the inclusion of a supplementary item on the Provisional Agenda shall be accompanied by a written explanation of the proposed supplementary item, which will be communicated to all CCMs and observers at least 20 days before the opening of the Session.

Other matters to be discussed, under Agenda Item 14, may be proposed here.

#### 1.3 Meeting arrangements

The Chair will outline procedural matters including the schedule for the meeting and administrative arrangements. According to the decision by the Commission and intersessional consultations with CCMs, the SC Chair will announce a revised structure of the SC meeting to be applied to SC6 where all Specialist Working Group meetings are absorbed into the plenary meeting.

The SC will select a Theme Convener for Management Issues Theme under Agenda Item 7.

It is the second year of Mr Naozumi Miyabe serving as the Chair of the SC. The SC will consider either the extension of one more term or the selection of a new SC Chair, including Theme Conveners if required, for 2011 session and thereafter.

# 1.4 Reporting arrangements

# Scientific Committee Report

The SC will adopt a Summary Report and, if available, an Executive Summary that will address requests from the Commission. Relevant text under Agenda Items highlighted with an asterisk (\*) in the Summary Report will be incorporated into the Executive Summary. The Executive Summary may also include a brief summary of research plans, findings or conclusions on the stock status, reports and recommendations as directed by the Commission or at the initiative of the SC (paragraph 2, Article 12 of the Convention).

The SC will have assistance of a professional rapporteur as the lead rapporteur. The SC will appoint supporting rapporteurs, who will be assigned to specific agenda items.

## Theme Sessions

The substance of topics presented, discussed and agreed within each Theme (including the Stock Status Theme) will be covered in the minutes of the main SC6 Summary Report and each Theme Convener will assist with the completion of their session minutes. However, the Stock Status Theme will also produce an additional report which will provide a detailed overview of each stock assessment presented and the main results and figures (as previously provided in the SA-SWG report). This Stock Status Theme report will be included as an Appendix to the SC6 Summary Report.

# 1.5 Intersessional activities of the Scientific Committee

The Chair, with support from the Secretariat, will report on intersessional activities of the SC and the Secretariat.

#### AGENDA ITEM 2 REVIEW OF FISHERIES

### 2.1 Overview of Western and Central Pacific Ocean (WCPO) fisheries\*

The SPC-OFP will present on fisheries for highly migratory species in the WCPO region. The SC will be invited to provide supplementary information, ask questions and provide comments.

#### 2.2 Overview of Eastern Pacific Ocean (EPO) fisheries

The IATTC will present on fisheries for highly migratory species in the EPO region. The SC will be invited to provide supplementary information, ask questions and provide comments.

# 2.3 Annual Report (Part 1) from Members, Participating Territories and Cooperating Non-Members (CCMs)

CCMs will be given the opportunity to make a brief presentation (3 minutes) highlighting recent changes and developments in their fisheries as described in Part 1 of their Annual Report to the Commission. A short time for questions may be provided at the conclusion

of each presentation. The deadline for the submission of Part 1 of the Annual Report to the Secretariat (<a href="wcpfc@wcpfc.int">wcpfc@wcpfc.int</a>) is 9 July 2010.

Presenters of CCM Annual Reports are required to prepare a half page summary (attached to Part 1 as "Summary of Part 1 of the Annual Report") to accompany their report for inclusion in the SC6 Summary Report. Rapporteurs will capture the key issues raised in subsequent discussion for inclusion in the Summary Report. It will be assumed that all reports have been read prior to the Session. The use of PowerPoint or other visual presentations is discouraged due to time constraints.

CCMs are requested to submit any outstanding Part 1 Reports for previous years, and the status of Part 1 submissions for each CCM can be found at the bottom of each WCPFC-SC meeting website (<a href="http://www.wcpfc.int/meetings/2">http://www.wcpfc.int/meetings/2</a>).

## 2.4 Reports from regional fisheries bodies and other organizations

Regional fisheries bodies and other intergovernmental or non-governmental organizations observing the SC may make a brief presentation (3 minutes) on key issues relevant to the work of the SC. Such presentations need to be arranged with the Chair before the opening of the Session. The deadline for the submission of meeting documents to the Secretariat (<a href="wcpfc@wcpfc.int">wcpfc@wcpfc.int</a>) from regional fisheries bodies and other intergovernmental or non-governmental organizations is 18 July 2010.
