SUMMARY OF ANNUAL REPORTS (PART 1 and 2) TO THE COMMISSION

WCPFC6-2009-IP03 16 November 2009

Introduction

Part 1 Reports

- 1. At the First Regular Session of the Technical and Compliance Committee (TCC1) in December 2005, Commission Members, Cooperating Non-Members and Participating Territories (CCMs) agreed to provide an Annual Report to the Commission. The purpose of this report is to provide information to the Commission on fisheries research and statistics during the preceding calendar year (Part 1), and management and compliance issues since the previous report (Part 2). Part 1 should be submitted one month before the regular session of the Scientific Committee (SC).
- 2. From 2006 to 2009 many of the Part 1 reports were submitted to the Secretariat well after the due date. At the time of writing of this paper the Secretariat had received Part 1 Reports for 2008 from 32 CCMs that are available to the Sixth Regular Session of the Commission (WCPFC6). Part 1 Reports are expected from 33 CCMs in 2009.

Part 2 Reports

- 3. WCPFC3 endorsed recommendations by the Second Regular Session of the Technical and Compliance Committee (TCC2) that:
 - a. the revised template for Part 2 of the Annual Report (Attachment K of the WCPFC3 Summary Report) be adopted for future reports;
- b. Part 2 of the Annual Report be completed on a calendar year basis and submitted to the Secretariat by 31 July each year;
- c. the Commission invite the SC to review Part 1 of the Annual Report in light of its relationship with Part 2, including its consistencies (such as reporting periods and submission times); and
- d. the Secretariat be tasked with preparing guidelines, including minimum standards, for the completion of Part 2 of the Annual Report. These guidelines should be focused to ensure that a minimum level of consistency is achieved without being overly prescriptive.
- 4. Part 2 of the report relating to management and compliance covering the period 1 January-31 December 2008 was to be submitted by 31 July 2009. Twenty-nine (29) CCMs have submitted Part 2 Reports which are available to WCPFC6¹.

Provision of Part 1 and Part 2 Reports on the WCPFC website

¹ France has advised that it has provided the Annual Report (Part 2) on behalf of French Polynesia, New Caledonia, and Wallis and Futuna. New Caledonia and French Polynesia have each provided an independent report.

5. Part 1 Reports are posted on the WCPFC website. Since Part 2 Reports are currently regarded as confidential, the Secretariat is not able to post them on the WCPFC website, but has instead posted them in the secure "CCM Section" on the WCPFC website.

Adoption of a new template for Part 1 Reports

7. The template for Part 1 was first prepared at TCC1. Following two years of discussion, the SC4 adopted a new template for Part 1 Reports (Attachment N of the SC4 Summary Report) that is available on the WCPFC website. All CCMs were required to use the newly adopted Part 1 Report template in 2009.

Formats used in the preparation of Part 2 Reports

- 8. Of the 29 Part 2 Reports provided to the Secretariat, 21 used the revised template contained in Appendix B of WCPFC5-2008/IP07 adopted by WCPFC5 as enhanced guidelines for Part 2 submissions and eight (8) used an independent reporting format.
- 9. At TCC5, the Secretariat noted the requirement in paragraph 40 of CMM 2008-01 for TCC to prepare a template for reporting on the implementation of CMM 2008-01 for their fishing vessels operating on the high seas and/or in waters under national jurisdiction. This template was circulated by the Secretariat to CCMs as WCPFC Circular 2009/06 in March 2009 and presented to TCC5 as an attachment to WCPFC-TCC5-2009/19 together with comments received from Australia and Japan. In addition to these comments, at TCC5 several other CCMs provided comments on the draft revised template.
- 10. TCC5 reviewed Secretariat paper "Revised Template for Annual Report, Part 2" (WCPFC-TCC5-2009/19) and directed the Secretariat to incorporate CCMs' suggestions in a revised Part 2 template for consideration at WCPFC6 (Attachment 1).
- 11. The Secretariat circulated enhanced guidelines on 29 October 2008, inviting CCMs to comment by 13 November 2009. At the time of writing this paper the Secretariat had received no comments on these guidelines from CCMs.

Discussion

12. If WCPFC6 can agree on a Part 2 Report template for 2010 this should greatly assist CCMs to meet the next reporting deadline of 31 July 2010, thus providing the Secretariat with sufficient material with which to prepare a comparative report for presentation at TCC6.

Recommendation

13. WCPFC6 is invited to:

- consider the information provided by CCMs in the Part 1 and Part 2 Reports available to the meeting;
- consider any additional advice or recommendations in relation to the format and guidelines for the Part 1 and Part 2 Reports;
- note the situation with respect to outstanding Part 1 and Part 2 Reports for activities by CCMs in 2005, 2006, 2007 and 2008;
- encourage those CCMs that have not already done so to submit their Part 1 and Part 2 Reports for the 2005, 2006, 2007 and 2008 activity periods;
- propose a Part 2 Report template for 2010; and
- consider and adopt a Part 2 Report template for 2010.
