PROPOSED WCPFC IUU VESSEL LIST FOR 2012

**WCPFC8- 2011/18 Rev 1
11 November 2011**

ISSUES:

1. Proposed WCPFC IUU Vessel List for 2012

In accordance with CMM 2010-06 paragraph 14 (i), TCC7 noted that there were no new submissions for WCPFC IUU Listing, consequently there is no Provisional IUU Vessel List for 2012. In accordance with CMM 2010-06, paragraph 14(ii) TCC7 reviewed the Current WCPFC IUU Vessels list for 2011 in accordance with CMM 2010-06, paragraphs 15-17. There are three issues regarding the list:

- a. There has been no further correspondence regarding the Georgian flagged vessel *Neptune*; or from members regarding the Chinese Taipei flagged vessel *Jinn Feng Tsair No. 1*; or the Chinese Taipei flagged vessel *Yu Fong 168*.
- b. The Secretariat wrote to Georgia and the owner of the Georgian flagged vessel *Fu Lien No 1*, formerly a vessel without nationality at the time of its listing on the IUU list, regarding their vessel and received notice that the vessel had been removed from their registry. No response from the owner has been received. TCC7 endorsed a mechanism to remove the vessel from the WCPFC IUU list should the owner ever approach the Commission with such an intent. This was to consider removal of the vessel from the list if the owner were to accept a sanction amounting to 10% of its cargo, or US\$150,000 as a sanction which considers the ability of the owner to pay such an amount as well as the value of the IUU fishing.
- c. Panama has requested and TCC7 endorsed the removal of the *Senta* (now *Sun Fu Fa*) based on the new mechanisms Panama has in place to exercise appropriate controls over its flag vessels including high seas licenses and VMS, and in addition after consideration of sanctions applied (US\$250,000 and ten months of detainment in port), as well as the change in ownership of the vessel with no links to the previous owner, thus fulfilling the requirement for removal under CMM 2010-06, paragraph 25.
