# SUMMARY OF REPORTING RECEIVED BY WCPFC IN ACCORDANCE WITH CMM 2012-01

# Additional FAD Set Reduction Notifications and Reporting (CMM 2012-01 paragraph 11)

1. In accordance with CMM 2012-01 paragraph 11, a 3 month purse seine FAD closure is to be implemented from 1 July - 30 September 2013, within EEZs and high seas waters located 20N and 20S. The rules to be applied during the FAD closure are described in CMM 2009-02.

2. In addition to the three month FAD closure, CCMs are to choose one of two options for additional FAD set reduction for their vessels (paragraph 11 of CMM 2012-01). WCPFC has received notifications from seventeen CCMs about their choice for additional FAD set reduction during 2013. Six CCMs notified their choice after 31 March, and two CCMs are yet to provide notification to WCPFC of their choice. A summary of the notifications under paragraph 11 of CMM 2012-01 is provided in Table 1.

3. Further, footnote 2 to paragraph 11 of CMM 2012-01, allows for SIDS to provide advice of certain vessels that can be exempted from the additional FAD set reduction requirement. WCPFC received advice from three small islands developing State CCMs of their flagged and chartered vessels that will not be subject to the additional reduction of FAD sets. These three notifications were received by WCPFC by 31 March 2013, and are summarized in footnotes to Table 1. To date, no further notifications have been received.

4. Most CCMs have chosen to have their flagged vessels implement the 4<sup>th</sup> month FAD closure (1- 31 October 2013). Three CCMs have chosen the alternative option of an annual limit on FAD sets. As at 25 November 2013, all three CCMs have provided some reporting in response to the requirements set out in Attachment B of CMM 2012-01. The reported number of FAD sets for 2013 year to date, compared to the FAD set limit is provided in the third column from the right, in Table 1.

5. Paragraph 2 of Attachment B to CMM 2012-01 requires that CCMs which have chosen to implement the annual limit on FAD sets option are to provide various reports on the status of implementation of the project. Three CCMs provided short statements in Annual Report Part 2, as well as a report to TCC9; one of the three CCMs provided a written paper (WCPFC-2013-TCC9-DP06) and has provided a paper to WCPFC10 on their activities (WCPFC10-2013-DP29).

# Advice on purse seine effort limits for other coastal States<sup>8</sup> (CMM 2012-01, paragraph 14)

6. CMM 2012-01 establishes purse seine EEZ limits for the members of the PNA (paragraph 12 of CMM 2012-01), and for CCMs that had more than 1000 days of purse seine effort which occurred its EEZ over the period 2006 - 2010 (paragraph 13). For other coastal State CCMs, with EEZs within the Convention Area 20N and 20S there is a reporting requirement set out in paragraph 14:

14. Other coastal States within the Convention Area other than those referred to in paragraph 12 and paragraph 13 shall establish effort limits or equivalent catch limits for purse seine fisheries within their EEZs that reflect the geographical distributions of skipjack, yellowfin, and bigeye tunas, and are consistent with the objectives for those species. Limits established pursuant to this provision shall be provided to the Commission by the relevant coastal States no later than 16 November 2013.

7. To date, eleven CCMs have provided advice to WCPFC Secretariat in accordance with paragraph 14 of CMM 2012-01 (Table 2). Table 2 will be updated as additional advice is received.

#### FAD Management Plans (CMM 2012-01, paragraph 24)

FAD Management Plan<sup>9</sup>

24. By 1 July 2009, CCMs fishing on the high seas shall submit to the Commission Management Plans for the use of FADs by their vessels on the high seas. These Plans shall include strategies to limit the capture of small bigeye and yellowfin tuna associated with fishing on FADs, including implementation of the

FAD closure pursuant to paragraphs 10 and 11(i) above. The Plans shall at a minimum meet the Suggested Guidelines for Preparation for FAD Management Plans for each CCM (Attachment E).

# Monthly reports of bigeye longline catches (CMM 2012-01 paragraph 27)

9. Paragraph 26 of CMM 2012-01 says "The catch limits for bigeye tuna shall be as specified in Attachment F." The reporting requirements related to bigeye longline catch limits under CMM 2012-01 are provided in paragraph 27. Each CCM with a limit specified in Attachment F is to provide a monthly catch report (catch for the month and year to date), for its flagged vessels by the end of the following month. To date the Secretariat has received monthly bigeye longline catch reports from ten CCMs. A summary of year to date reported bigeye catches compared to the 2013 limits under CMM 2012-01 is shown in Table 4. It should be noted that many CCMs have advised the Secretariat at the time of providing their monthly reports that the reported catches are provisional estimates and maybe subject to revision.

WCPFC – IATTC Overlap Area (WCPFC9 Decision, paragraph 80)

10. The WCPFC9 decision on the application of measures in the part of the WCPF Convention Area that overlaps with the IATTC Convention Area is relevant to the bigeye longline catch limits and reporting (see WCPFC9 Summary Report, paragraph 80). In the case of a WCPFC member who is also an IATTC member, and who has vessels on both records/register of IATTC and WCPFC, the corresponding flag Member shall decide and notify both organisations under which of the two Commissions those vessels shall operate when fishing in the overlap area with IATTC and WCPFC. If a CCM is a member of only one RFMO, the rules of the RFMO of which it is a member apply in the overlap area between WCPFC and IATTC, even if the CCM is a cooperating non-member of the other RFMO. In accordance with this WCPFC9 decision and the relevant notifications received by WCPFC to date the following three CCMs are able to exclude catches taken by certain vessels, from being counted against their CMM 2012-01 bigeye longline catch limit:<sup>13</sup>

• Belize – As a WCPFC Cooperating Non-Member which is a contracting party of IATTC;

- European Union in accordance with letter received by WCPFC on 2 April 2013; and
- Republic of Korea in accordance with advice received by WCPFC on 8<sup>th</sup> July 2013.

Of these three CCMs, to date only Korea has provided reports of total estimated catches by month of bigeye and yellowfin longline tuna for the overlap area with IATTC (the reported catches in the overlap area is shown in the right-most column of Table 4).<sup>14</sup>

# Reporting of 2013 yellowfin catches by longline as at 31 October 2013 (CMM 2012-01 paragraph 28)

#### Yellowfin

CCMs are encouraged to take measures not to increase their catch of yellowfin tuna. Each CCM shall report to WCPFC10 its 2013 catch of yellowfin tuna as of October 31.

11. At the time of writing the WCPFC Secretariat had received reports from eight CCMs; two are partial reports (Table 5). Table 5 will be updated as additional reports from CCMs are received.
