SUMMARY OF ADVICE PROVIDED BY CCMS IN ANNUAL REPORT PART 2 2014 ON METRIC USED TO CALCULATE PERCENTAGE OF LONGLINE OBSERVER COVERAGE IN 2013

- 1. During 2013 it was recognized through the Compliance Monitoring Report process that there were challenges in making the compliance assessments without clear information from CCMs on the metric they used to calculate the percentage of longline observer coverage. Consequently, WCPFC10 agreed that CCMs should identify in Annual Report Part 2 the metric used to calculate the percentage of longline observer coverage in 2013¹
- 2. The table below summarises the information that CCMs have provided in Annual Report Part 2 2014 (covering 2013 activities on the metric used to calculate the percentage of longline observer coverage in 2013), as at 3 August 2014. There may be other sources of advice from CCMs to WCPFC on the metric used to calculate longline coverage which are not included here.
