# AGENDA ITEM 1 OPENING OF MEETING

# 1.1 Welcome

The Chair (Ms Rhea Moss-Christian) will open the Tenth Regular Session of the Technical and Compliance Committee (TCC10) of the Western and Central Pacific Fisheries Commission (WCPFC) and welcome delegations of the WCPFC Members, Cooperating Non-Members, Participating Territories (CCMs) and Observers.

# **1.2** Adoption of agenda

The Chair will introduce the Provisional Agenda for TCC10 (WCPFC-TCC10-2014/02) that was distributed in accordance with Rule 1 of the Commission's Rules of Procedure. The Rules of Procedure adopted at WCPFC1 in December 2004 will apply *mutatis mutandis* until such time as the TCC adopts its own Rules of Procedure (Rule 31). The Rules of Procedure provide that Members may propose supplementary agenda items up until 30 days before the meeting (Rule 3). The Agenda, as modified, will need to be adopted by the meeting (Rule 5).

The Chair will invite TCC10 to review the Indicative Schedule, noting logistical arrangements in place to support the meeting, proposed meeting times and any social events.

# AGENDA ITEM 5 SPECIAL REQUIREMENTS OF DEVELOPING STATES

In accordance with Rule 2 (h) of the WCPFC Rules of Procedure, *Consideration of the Special Requirements of Developing States pursuant to Part VIII of the Convention* is a standing agenda item on the provisional agenda. In the past, developed CCMs provided reports on initiatives to implement Article 30, specifically in relation to the activities and work program of the TCC.

TCC10 is invited to discuss the special requirements of developing States as it relates to the work of TCC, noting that:

i) the approved TCC workplan 2013-2015 identified that a TCC priority was to "give effect to obligations related to Small Island Developing States";

ii) At WCPFC10 two new CMMs were approved CMM 2013-06 *Conservation and Management Measure on the criteria for the consideration of conservation and management proposals* and CMM 2013-07 *Conservation and Management Measure on the special requirements of SIDS and participating territories.*

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015.

# AGENDA ITEM 6 COMPLIANCE MONITORING SCHEME

This is the fourth year of implementation for the WCPFC Compliance Monitoring Scheme. At WCPFC10, adopted CMM 2013-02 *Conservation and Management Measure for Compliance Monitoring Scheme* which applies for 2014 only.

## 6.1 Review of draft CMR

In accordance with CMM 2013-02 TCC10 is to review the full Draft Compliance Monitoring Report (CMR) prepared by the Secretariat in the form agreed by WCPFC10. Potential compliance issues will be identified for each CCM, based on information contained in the dCMRs as well as any information provided by CCMs in accordance with paragraph 12 of CMM 2013-02.

Noting that draft and provisional CMRs constitute non-public domain data, the review of draft CMRs will held taking into account the confidentiality of information (CMM 2013-02 para 14).

## 6.2 **Provisional CMR report and Executive Summary**

In accordance with CMM 2013-02 paragraphs 14 and 15, TCC10 shall take into account any additional information provided by CCMs, and where appropriate non-governmental organizations and other organizations, and develop a Provisional CMR that will include a provisional assessment of each CCMs Compliance Status and recommendations for any corrective action needed, based on potential compliance issues it has identified in respect of that CCM and using the criteria and considerations for assessing Compliance Status set out in Annex I of CMM 2013-02.

The Provisional CMR will also include an executive summary including recommendations and observations from TCC regarding: (i) Identification of any CMMs that should be reviewed to address implementation or compliance difficulties experienced by CCMs, including any specific amendments or improvements that have been identified (**TCC10 Agenda 6.4**),

(ii) capacity building requirements or other obstacles to implementation identified by CCMs, in particular small island developing State Members and Participating Territories, (TCC10 Agenda 6.3) and
(iii) additional priority obligations that should be reviewed under the CMS pursuant to paragraph 5 of

## this measure (TCC10 Agenda 6.5).

## 6.3 Target capacity assistance to areas of need identified by CMR process

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015, noting linkages to recommendations that may be made by TCC in the Provisional CMR Executive Summary.

# 6.4 Recommendations to revise CMMs prioritized by CMS process which were ambiguous or problematic (TCC Workplan 2013-2015)

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015, noting linkages to recommendations that may be made by TCC in the Provisional CMR Executive Summary.

# (a) Expiry of VMS manual reporting position reporting requirements on 1 March 2015 (VMS SSPs, Section 5)

WCPFC10 agreed to extend the VMS Manual Reporting provisions (section 5 of VMS SSPs) until 1 March 2015. TCC is invited to discuss and as appropriate make recommendations on this matter.

# (b) Review SLAs with Mobile Satellite Provider, develop ALC type approval process – (TCC workplan 2013-2015)

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015.

## 8.2 Regional Observer Programme

The WCPFC Secretariat will be invited to introduce the ROP Annual Report (RP02).

#### (a) Measuring and monitoring ROP longline coverage (TCC9 para 117)

During TCC9 consultations had taken place between the Secretariat, SPC and CCMs on Table 1 of WCPFC-TCC9-2013/09 and associated issues should continue intersessionally. WCPFC10 agreed with TCC9 recommendation that CCMs identify in their 2014 Annual Report Part 2 which metric they used to calculate the percentage of longline observer coverage for 2013 (TCC9 report para 117). TCC10 is invited to review the new information, further discuss and as appropriate make recommendations on this matter.

## (b) ROP and addressing corruption concerns (TCC9 para 184 and 204)

TCC9 recommended that the WCPFC10 task the WCPFC Secretariat with developing and circulating prior to TCC10 a paper on a Minimum Standard in relation to mechanisms on how to prevent and stop misconduct of observers. Comments should be provided and the paper adjusted and then presented for discussion and endorsement at TCC10. (TCC10 paragraph 184). TCC9 also agreed that responses from members about how to best deal with corruption issues, such as those involving blackmail, bribery and extortion, should be tabled for discussion at TCC10. (TCC9 paragraph 204). TCC10 is invited to review any new information, further discuss and as appropriate make recommendations on this matter.

#### (c) Notification requirements for monitoring observer coverage on carriers involved in high seas transshipment activities (TCC9 para 177)

TCC9 considered issues associated with transshipment vessel movement and observer coverage notifications. TCC9 could not reach consensus on the need for notification requirements for fish carrier vessels and transshipment observers. TCC9 agreed to continue discussions on the need for notification requirements for fish carrier vessels and transshipment observers at TCC10. (TCC9 para 177). TCC10 is invited to review any new information, further discuss and as appropriate make recommendations on this matter.

# (d) Annual list of changes required to observer training programmes (TCC8, para 33) and observer handbook of CMMs (TCC9 para 206)

TCC8 requested the WCPFC Secretariat consider providing an annual list of changes required to the observer training programmes based on changes in Commission CMMs, rules and procedures. TCC9 tasked the Secretariat with preparing an observer handbook of CMMs (TCC9 report para 206). The Secretariat will provide updates on these initiatives. TCC10 is invited to discuss and as appropriate make recommendations on this matter.

### (e) Mechanism for observer data to be provided to the Master/Vessel Operator/Captain – (TCC workplan 2013-2015)

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015.

# (f) Funding or IT capacity in place to maintain observer data provision (TCC workplan 2013-2015)

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015.

# 8.3 High Seas Transshipment Monitoring

The WCPFC Secretariat will be invited to introduce the High Seas Transshipment Monitoring Annual Report (RP03).

## (a) MCS implications of high seas transshipment (TCC9 para 268)

TCC9 recommended that the Commission task the Secretariat to provide a report at TCC10 with specific details of transshipment activity in 2013/2014, including through using the VMS tool described by the Executive Director. To the extent possible, available ROP observer data will be included in this Analysis (TCC9, para 267) TCC10 agreed to revisit the MCS implications of high seas transshipment pending that report, and the outcomes of the CMS process on this CMM at TCC10. (TCC10, para 268)

## 8.4 High Seas Boarding and Inspection (HSBI)

The WCPFC Secretariat will be invited to introduce the High Seas Boarding and Inspection (HSBI) Annual Report (RP04).

(a) Review implementation and effectiveness(TCC workplan 2013-2015)

TCC10 is invited to discuss this priority project specific task which was included in the approved TCC workplan 2013-2015.

# 8.5 Record of Fishing Vessels (RFV)

The WCPFC Secretariat will be invited to introduce the Record of Fishing Vessels (RFV) Annual Report (RP05).

# (a) Secretariat recommended improvements or modifications to RFV SSPs (para 14 – 15 of CMM 2013-03)

In accordance with CMM 2013-03, the Record of Fishing Vessels Standards Specifications and Procedures (RFV-SSPs) were implemented from early June 2014. Paragraph 14 and 15 of CMM 2013-03 provides an opportunity for the Secretariat to, as necessary make recommendations for improvements or modifications to the RFV SSPs, including consistency with international standards and codes. TCC10 is invited to discuss and as appropriate make recommendations on this matter.

## 8.6 Eastern High Seas Pocket Special Management Area (EHSP-SMA)

The WCPFC Secretariat will be invited to introduce the EHSP-SMA Annual Report (RP06). TCC10 is invited to discuss and as appropriate make recommendations on this matter.
