SUMMARY OF CURRENT WCPFC CHARTER NOTIFICATIONS
UNDER CMM 2012-05

WCPFC11-2014-IP01

1. The WCPFC Charter Notification Scheme is governed by Conservation and Management Measure 2012-05 (which replaced CMM 2011-05 and CMM 2009-08).
2. In accordance with CMM 2012-05, each chartering Member of Participating Territory can choose to notify the Commission of any vessel to be identified as chartered in accordance with the CMM by sending a notification containing the information in paragraph 2 to the Executive Director and to the flag CCM. The notification by a Commission member or participating territory of a charter, lease or other mechanisms involving vessels flagged to a another CCM, means that the vessel can be considered to be an integral part of the domestic fleet of that chartering Member or Participating Territory.
3. Paragraph 5 of CMM 2012-05 instructs the Executive Director to make available to all CCMs information submitted under CMM 2012-05. Information received from CCMs on charter arrangements can currently be found in two places on the WCPFC Intranet.
 - I. As part of the Record of Fishing Vessels: where flag CCMs reporting to confirm charter arrangements for their vessels are submitted in accordance with CMM 2013-03 (CMM 2013-03, RFV SSPs).
 - II. In the Charter Notification List maintained by the Secretariat, which records advice that chartering Members or chartering participating territories have advised the Secretariat as well as the appropriate flag CCM, in accordance with the WCPFC Charter Notification Scheme (CMM 2012-05 or its predecessor)
4. As at 22 November 2014, six CCMs have notified the Executive Director of a total of 202 vessels which in accordance with CMM 2012-05 should be considered to be an integral part of the domestic fleet of that chartering Member or Participating Territory. In accordance with paragraph 6 of CMM 2012-05, a summary of the current list of notified charter vessels is presented in Table 1.
