<u>Draft</u> proposed work plan to progress WCPFC's consideration of a management framework as proposed by MOW3

To successfully continue this work will require that objectives and associated management approaches are comprehensively examined, tested, compared and that a wide range of options is developed in order to inform negotiations and facilitate the achievement of agreement on binding and effective measures. Suggestions for management approaches should be driven by CCMs, noting that this work must not undermine the in-zone management arrangements that CCMs, and especially members of PNA, have developed, or are developing. The intention is that under the compatibility principle, these arrangements must be given due recognition in undertaking the analysis proposed under this work plan.

The benefits and costs of different management options will need careful consideration, with attention given to the burden of conservation and in particular, avoidance of disproportional burden on SIDS as per Article 30 of the Convention and time-frames for implementation.

Success will also require that the options are examined in a transparent and participatory process so that all CCMs have input and engagement with the testing and comparison of candidate harvest strategies. To support the work necessary to underpin negotiation and agreement of a framework for establishing harvest strategies at the Commission the following approach, to be implemented over a three-year period, is suggested.

The current proposed budget to support this work focuses on three main areas:

It is understood that the FAO Marine Areas Beyond National Jurisdiction (ABNJ) project could provide funding for work area 3 above.

The purpose of this short paper is to provide further details of what tasks could be undertaken in 1-3 above. We provide this in the context of a three-year plan in the first instance with specific deliverables identified for each year and consideration of the key fisheries. Activities and deliverables relate to the SSP unless otherwise noted.

In preparing this table we noted the following assumptions:

• Funding would need to be confirmed within the first quarter of 2015 to allow the delivery of the work planned for this year

- Funding and assistance to support these activities outside the Commission budget could be considered which may assist with various elements of the work plan, such as from an NGO or the EU proposed funding of 50,000 Euros for a workshop and/or technical assistance for MSE work from other sources, e.g., the EU.
- It is best practice to get preliminary analyses in front of the stakeholders to get feedback to allow further work before any decision is made.
- The work would require working closely with key stakeholders in each fishery and with the Pacific Islands Forum Fisheries Agency and WCPFC bodies. As an example PNA would be a key stakeholders driving the proposed work on the tropical purse seine fishery.
- Depending on funding, work undertaken here could also be presented at non-WCPFC forums.
