Philippine Report for the CMM 2014-04 on the Pacific Bluefin tuna

Paragraph 5 of the CMM 2014-04 requires CCMs to report as follows:

5. CCMs shall report their 2002–2004 baseline fishing effort and <30 kg and >=30 kg catch levels for 2013 and 2014, by fishery, as referred to in the preceding two paragraphs, to the Executive Director by <u>31 July 2015</u>. CCMs shall also report to the Executive Director by <u>31 July each year</u> their fishing effort and <30 kg and >=30 kg catch levels, by fishery, for the previous year, accounting for all catches, including discards. The Executive Director will compile this information each year into <u>an appropriate format</u> for the use of the Northern Committee.
