DRAFT COMPLIANCE MONITORING REPORT - INTRODUCTION

WCPFC-TCC7-2011/17 9 September 2011

ISSUES:

- 1. CCMs are obligated to report on the implementation of Conservation and Management Measures (CMMs). WCPFC6 adopted the recommendation that the Secretariat attribute reporting gaps to the CCMs concerned. WCPFC7 adopted a new Compliance Monitoring Scheme through CMM 2010-03 highlighting the need to evaluate compliance of CCMs to:
 - i. catch and effort limits:
 - ii. catch and effort reporting;
 - iii. spatial and temporal closures and gear restrictions;
 - iv. observer and VMS requirements; and
 - v. scientific data provision, reporting and handling.
- 2. Compliance with these five issues this year is addressed in the format noted in WCPFC-TCC7-2011-IP-01 *Draft Compliance Scheme Monitoring Report (CMR)*. The CMRs are compiled for each CCM from information provided in Part 1 and Part 2 Annual Reports, VMS, ROP, RFV, Scientific data provided to the Commission, and other reporting requirements noted in CMMs. A total of 19 Part 2 Annual Reports were received by 7 September, and the package of 19 individual CCM Compliance Monitoring Reports for 2010 Activities is found at http://wcpfc.int/ccm/compliance-monitoring-reports, on the non-public domain side of the WCPFC website. These comprise the Draft Compliance Monitoring Report (Draft Report) for 2010 from which TCC is to compile a Provisional Compliance Monitoring Report (Provisional Report) for the Annual Commission Meeting.
- 3. The CMRs are required to be sent back to CCMs for review 5 days after receipt of the Part 2 Annual Report or 25 days prior to TCC, whichever is earlier. Part 2 Annual Reports are due to the Secretariat 30 days prior to TCC. There are 25 members, 7 Participating Territories and 9 Cooperating Non-Members who would complete Annual Reports each year, which leaves 5 days to compile and disseminate 37-41 individual reports in the aforementioned format to the respective CCMs for comment. Comments

are due back to the Secretariat 12 days prior to TCC and the Secretariat has 5 days to input comments and disseminate all the reports in one package to all CCMs for review at TCC. This time frame does not allow for any detailed analysis of individual reports for factors impacting compliance or assessment of major compliance issues.

- 4. The current CMRs do not address all compliance issues in the CMMs or Commission decisions. Those issues not addressed in the current CMR are elaborated in **Attachment 1** with the reporting/action requirements presented in a format similar to the current CMR. Some challenges facing the proposed Compliance Monitoring report scheme include:
 - very short submission time which does not permit time for appropriate analyses and evaluation of the submission, further discussed in WCPFC-TCC7-2011/18 and WCPFC-TCC7-2011/19;
 - the lack of clear and standard evaluation measure for reports, however, it is noted that this may evolve over time; and
 - no fixed and clear baseline of data against which to measure progress with respect to compliance.

DECISIONS/ENDORSEMENTS

- 5. TCC7 is invited to review the CMRs and compile the Provisional Report for the Annual Meeting. The proposed format for the individual provisional CMRs is attached as **Attachment 2.**
- 6. TCC7 is invited to review CMM 2010-03, as it is due for review by the Commission at its annual meeting later this year. Options to consider may include:
 - -extension of the CMR format to include all reporting requirements in CMMs and Commission decisions;
 - a strategy to synthesize the CMRs' compliance issues from individual CCM reports, develop options to rectify the issues and enable the Commission to decide on such recommendations to address compliance problems on a wider scale than that of individual CCMs.

Provisional Compliance Monitoring Report

In accordance with CMM 2010-03 *Conservation and Management Measure for Compliance Monitoring Scheme*, the TCC is required to develop a Provisional Compliance Monitoring Report that includes:

- a provisional assessment of each CCM's Compliance Status and recommendations for any corrective action needed (paragraph 14)
- recommendations for amendments or improvements to existing CMM to address implementation or compliance difficulties experienced by CCMs (paragraph 15(i)), and
- recommendations or observations for additional priority obligations that should be reviewed under the Scheme pursuant to paragraph 4 of the CMM (paragraph 15(ii)).

To give effect to the first requirement, TCC could use a simple template to provide a provisional assessment of each CCM's compliance status, setting out:

- 1. a summary of any potential compliance issues identified with respect to each CCM in relation to the five categories of obligation with which compliance is monitored under the Scheme (para 3), and
- 2. a provisional assessment of compliance status for each CCM.

The template could be along the following lines:

- (i) Catch and effort limits

(iii) Spatial and temporal closures, and gear restrictions

[compliant/failed to give effect to [observer or VMS requirement] or failed to take action with respect to vessel/s breaching [observer or VMS requirement]]

(v) Scientific data provision, reporting and handling
