Issues to be addressed from the Independent Review of the Commission's Transitional Science Structure and Functions

Introduction

- 1. The paper WCPFC-SC5-2009/GN-WP-08 was considered at SC5 identifying summary issues from the *Final Report on Independent Review of the Commission's Transitional Science Structure and Functions* (WCPFC-SC5-2009/GN-WP-07) produced by Marine Resources Assessment Group (UK). The Scientific Committee's response to the issues raised in the paper was recorded as Attachment Q of the SC5 Summary Report.
- 2. WCPFC6 endorsed SC5's recommendation on paragraph 404 ("SC5 recommended that issues from Attachment Q that require further discussion be raised with WCPFC and its subsidiary bodies at subsequent meetings"). The table below lists the issues for further consideration.

ISC's Statistics WG briefly compared the WCPFC and ISC inventories and found few differences. ISC corresponded with SPC's database manager during the meeting to resolve any issues. ISC has not yet provided their data inventory to WCPFC. Given the situation, the Secretariat will continue to liaise with ISC to obtain its data inventory and complete the report on data gaps by October 1 st , 2010. An earlier draft of ST-WP-03 was presented to ISC with options of draft mechanisms for the periodic exchange of data to address gaps in the data for North Pacific stocks. The ISC preferred the option of having annual consultative meetings between ISC and WCPFC, and possibly IATTC. The SC may choose to develop terms of reference for these annual consultative meetings, and to send

		this to ISC and IATTC for their input.
