### Cook Islands, Fiji, Niue, Samoa, Tonga and Vanuatu: DRAFT BRIDGING MEASURE FOR TROPICAL TUNAS REV. 5

#### **Explanatory Note**

- 1. The Cook Islands, Fiji, Niue, Samoa, Tonga, and Vanuatu are SIDS, WCPO coastal states, founding members of the WCPFC, members of the FFA and parties to The Multilateral Treaty on Fisheries Between Certain Governments of the Pacific Island States and the Government of the United States of America. These States play an active role in the management of the WCPFC fisheries but are not currently members of the PNA.
- 2. The States have all declared conservative EEZ purse-seine effort limits taking into account historical catches, geographical and biological information.
- 3. The declared EEZ limits are Cook Islands (1,250 vessel days), Fiji (300 vessel days), Niue (200 vessel days), Samoa (150 vessel days), Tonga (250 vessel days), and Vanuatu (200 vessel days), totalling **2,350 vessel days**.
- 4. Most States have limited purse-seine catch history, and none have exceed the threshold of 1,500 vessel days set out in paragraph 22 of CMM 2016-01.
- 5. None of the States have yet achieved their aspirations to fish their EEZ purse seine effort limits and fully develop domestic fisheries.
- 6. These States are exempt from restrictions to fishing on the High Seas. One State has purse seine vessels on the WCPFC RFV, but the rest have no immediate intentions to register vessels under their flag.
- 7. In order to utilise their SIDS aspirational rights and develop rights in respect of the fisheries resources in their EEZs these States are seeking a measure under the Tropical Tuna CMM that will enable their EEZ limits to be transferred between their EEZs and other (cooperating) EEZs, or to the High Seas areas to vessels flagged to other CCMs, subject to a specified notification processes.
- 8. The States will continue to honour the EEZ vessel days committed to existing treaties and partnerships and these vessel days will only be expended within EEZs and not eligible for transfer to the High Seas. Currently 950 vessel days are committed to States EEZs under the US Treaty leaving a maximum of **1,400 vessel days** that could potentially be transferred to the High Seas.
- 9. States will limit the transfer of their EEZ effort limits to the 2016 skipjack stock assessment **Region 3**, as this geographical area has biological connectivity to their EEZs
- 10. The States also acknowledge the status of High Seas Pockets in Region 2 and Region 3, adjacent to States EEZ and commit not to transfer effort or vessel days to those High Seas pockets.

#### **Proposed Preamble Text**

#### **Small Island Developing States**

*In giving effect to this CMM, the Commission shall note;* 

- *i)* that Article 30(2)(b) of the Convention requires the Commission to avoid adverse impacts on subsistence, small-scale and artisanal fishers; and,
- ii) that Article 10(3)(h) of the Convention requires the Commission to take into account, inter-alia, the special circumstances of a State which is surrounded by the exclusive economic zones of other States and has a limited exclusive economic zone of its own;

#### 1. Proposals for section titled "Zone-based purse seine effort control"

Cook Islands, Fiji, Niue, Samoa, Tonga and Vanuatu support the PNA proposal in paragraph 22 of the Chair's Rev 4 measure. The limits to be specified for these States in the proposed table would be:

#### 2. Proposals for section titled "High seas purse seine effort control"

#### Cook Islands, Fiji, Niue, Samoa, Tonga and Vanuatu: Effort Limits

23) The declared EEZ effort limits of the Cook Islands, Fiji, Niue, Samoa, Tonga, and Vanuatu shall be eligible for transfer to the high seas including to be used by vessels flagged to another CCM pursuant to the following conditions:

- i. The details of the proposed transfer, including the number of vessel days and details of any participating vessel are to be notified to the Executive Director at least 10 days before fishing in the high seas takes place; and
- ii. Transfer of effort to the High Seas will only occur in the geographical limits for High Seas transfer shown in the map attached.
