### DRAFT IUU VESSEL LIST AND CURRENT WCPFC IUU VESSEL LIST

WCPFC-TCC13-2017-08 31 August 2017

#### Paper prepared by the Secretariat

#### Purpose

- 1. The paper presents for the consideration and decision of TCC13:
  - a) the draft IUU vessel list and supporting documentation; and
  - b) the current WCPFC IUU vessel list.

#### Background

2. The Seventh Regular Session of the Commission (WCPFC7) adopted Conservation and Management Measure 2010-06 (CMM 2010-06) entitled 'Conservation and Management Measure to Establish a List of Vessels Presumed to Have Carried Out Illegal, Unreported and Unregulated Fishing Activities in the WCPO' (which replaced CMM 2007-03). CMM 2010-06 requires the Executive Director to prepare a draft IUU Vessel List based on information received from Members, Cooperating Non-Members and Participating Territories (CCMs) at least 70 days before the annual meeting of the Technical and Compliance Committee (TCC). CMM 2010-06 further requires the Executive Director to transmit the draft IUU Vessel List, together with all the supporting evidence provided, to all CCMs, as well as to non-CCMs with vessels on the list, at least 55 days before the annual meeting of the TCC.

#### Vessels presumed to have undertaken IUU activity

3. On 31 July 2017 the draft IUU Vessel List and supporting information was circulated to all CCMs and other relevant flag CCMs (WCPFC Circular 2017/54). The draft IUU Vessel List considered notification from Australia, Cook Islands and New Zealand of their list of vessels presumed to have undertaken IUU activities.

- 4. Since the circulation of the draft IUU Vessel List and supporting documentation on 31 July 2017, one submission of additional supporting documentation has been received:
  - i. On 30 August 2017 the Cook Islands provided an update confirming a settlement had been reached regarding the alleged IUU activities of vessel *Sui Yuan Yu 30*. This advice was circulated to CCMs as Circular 2017/60).
- 5. A copy of the draft IUU Vessel List is provided in **Annex 1.** Copies of suitably documented information that relates to the draft IUU Vessel List and the current WCPFC IUU Vessel List can be accessed by authorized CCM users from the WCPFC secure CCM side of the website

#### **Current WCPFC IUU Vessel List**

6. The WCPFC IUU Vessel List for 2017 includes no new vessels and maintains those from the previous year's list. At WCPFC13, the Commission decided to expand the information contained in the WCPFC IUU Vessel List to include the Vessel Masters name and nationality. #### Recommendation

- 7. TCC13 is invited, pursuant to CMM 2010-06, to:
  - a) adopt a Provisional IUU Vessel List, and submit it to the Commission for consideration and approval; and
  - b) recommend, as appropriate, any proposed changes to the current WCPFC IUU Vessel List.

<sup>&</sup>lt;sup>1</sup> **Supplementary note as at 8 Dec 2015:** In October 2015, at the request of TCC11 the Executive Director sent letters to: Chinese Taipei and Georgia to request information of their vessel/s on the WCPFC IUU list, specifically their last known operations and whereabouts; and to other RFMOs (CCAMLR, CCSBT, IATTC, ICCAT, IOTC, NPAFC & SPRFMO) to seek their cooperation with locating the vessels on the WCPFC IUU list underlining that they are now listed on a number of IUU lists. Georgia replied to confirm that the vessels **Neptune** and **Fu Lien No 1** are no longer flying Georgia flag. Chinese Taipei confirmed that with respect to **Yu Fong 168**, the license was revoked in 2009 the owner of the vessel has been penalized through repeated monetary punishment for violating the rules of not returning to port. Chinese Taipei further advised that the most recent information was received from Thailand's notification to IOTC that the vessel landed their catches in the port of Phuket in the year 2013. CCAMLR and NPAFC replied and confirmed that there are no updates to provide, and ICCAT confirmed that the three vessels are included on the provisional IUU list which will be considered for adoption at the forthcoming ICCAT meeting, 10-17 November 2015.
