LEGAL ANALYSIS OF WCPFC CMM 2008-01

WCPFC8-2011-47 27th March 2012

Paper prepared by Legal Adviser

- 1. This paper responds to a request by some CCMs for the Legal Adviser to provide analysis of CMM 2008-01 in terms of the paragraphs which have expired and those which are continuing.
- 2. CMM 2008-01 is a very complex Measure. Many of the paragraphs are capable of different interpretations. In the absence of full knowledge of what the exact intent of the Members were when they adopted the Measure, a textual interpretation has been adopted in this analysis.
- 3. Based on the analysis, it can be concluded that most of the substantive provisions of CMM 2008-01 which are linked to specific years (i.e. 2009, 2010, and 2011) have expired.
- 4. Although provisions which are not time-bound do not expire, some of the provisions will require revision such as those that are linked to conservation and management measures which have been amended or those that are linked to provisions which have expired.
- 5. For easy reference, the analysis is presented in a matrix format (Appendix).

7	Paragraphs 23-30	All of these titles come under separate headings and NOT part of the heading: "Measures for 2010-2011" and do not expire.
12	Longline Fishery Paras 31-38	These provisions expire.
		Note : The interpretation of paragraph 31 is a bit unclear and could be read as continuing, particularly the second part which provide "The catch of yellowfin tuna is not to be increased in the longline fishery from the 2001-2004 levels." However, the paragraph, read together with the rest of the paragraphs (i.e. paras 32, 33, 35, 36) under the same section can lead to the conclusion that the paragraphs expire because they relate to the 2009-2011 period.
13	Para 39-45	These paragraphs are not time-bound and therefore do not expire.
18	Review of Measures	This provision can either be read to expire or require revision.
	Para 46	There is a potential contradiction in paragraph 46 where it states"The measure shall remain in place unless the Commission adopts alternative measures." However, read together with the rest of the measure as a whole, in particular the time bound provisions highlighted above, can lead to the conclusion that this provision expires or requires revision.
19	Final Clause Para 47	This provision does not expire but requires revision
