# SUMMARY OF NOTIFICATIONS TO WCPFC OF CHARTER, LEASE OR OTHER MECHANISMS

# Paper by Secretariat

#### Purpose

1. This paper tables for the information of and review by the Commission a summary of all notified chartered vessels. This paper is submitted in response to paragraph 6 of CMM 2016-05 *Conservation and Management Measure for the Charter Notification Scheme*.

# Background

- 2. Since 2010, the WCPFC has had a Charter Notification Scheme under various versions of the CMM on Charter Notification. The current measure in force is CMM 2016-05.<sup>1</sup>
- 3. In accordance with CMM 2016-05 paragraphs 2 and 3, each Member or Participating Territory can choose to notify the Commission of any vessel to be identified under the Charter Notification Scheme, for the purpose of conducting fishing operations in the Convention Area as an integral part of the domestic fleet of that chartering Member or Participating Territory.
- 4. Paragraph 7 of CMM 2016-05 also states: "Unless specifically provided in other CMMs, catches and effort of vessels notified as chartered under this CMM shall be attributed to the chartering Member or Participating Territory. Unless specifically provided in other CMMs, the chartering Member or Participating Territory shall report annually to the Executive Director catch and effort of chartered vessels in the previous year."

## Overview

5. Paragraph 5 of CMM 2016-05 tasks the Executive Director to make available to all CCMs information submitted under CMM 2016-05. Information received from CCMs on charter arrangements can currently be found in two places on the WCPFC Intranet.

I. As part of the Record of Fishing Vessels: where flag CCMs are expected in accordance with the RFV SSPs to confirm charter arrangements for their vessels are submitted in accordance with CMM 2014-03 (CMM 2014-03, RFV SSPs).

II. In the Charter Notification List maintained by the Secretariat, which records advice that chartering Members or chartering participating territories have advised the Secretariat as well as the appropriate flag CCM, in accordance with the WCPFC Charter Notification Scheme (CMM 2016-05 or its predecessor)

- 6. In 2018, as at 28 November 2018, the Secretariat received 39 submissions from 10 Members and Participating Territories containing notifications or updates related to the Charter Notification Scheme. At the time of writing this paper there were a total of 395 individual vessels (383 longliners and 12 purse seine vessels) that are notified under the Charter Notification Scheme during the 2018 calendar year. In addition there was one (1) individual longline vessel, that is notified under the Charter Notification Scheme for part of the 2019 calendar year.
- 7. In accordance with paragraph 6 of CMM 2016-05, a summary of the list of notified charter vessels, with annual counts of individual vessels by Charter Notification period are presented in **Annex 1** attached to this paper.
