It is noted, however, that the operation of the revised Rule 36 in relation to the above IGOs may not be consistent with the provision of Article 22 of the WCPFC Convention and inconsistent with some of the MOUs of Cooperation between the WCPFC and some of those IGOs. In addition, NGO observers from some of the organisations listed in paragraph 3 have attended meetings of WCPFC or its subsidiary bodies as members of CCM delegations.

Recommendation

5. WCPFC16 is invited to note this paper and provide any guidance on the implementation of Rule 36.
