Subject: US delegation papers for WCPFC17 and request for supplemental agenda item

Dear Feleti,

On behalf of Mr. Drew Lawler, head of the US delegation to WCPFC17, please find attached the following two papers, which we ask that you make available to the other delegations:

- 1. US proposal for the tropical tunas measure (for discussion under provisional agenda items 4, New Proposals, and 7.2.2.4, New CMM for tropical tunas).
- 2. US discussion paper on cetacean handling guidelines (which we suggest could be discussed under provisional agenda item 14, Other Matters).

In addition, we would like to request inclusion of a supplemental agenda item: Rebuilding of North Pacific striped marlin.

This supplemental agenda item is to address the need to rebuild the stock in accordance with the Interim Rebuilding Plan for North Pacific Striped Marlin adopted by WCPFC16. The strategy in the plan states that "Beginning in 2020, and based on the best scientific information available, members will develop measures to rebuild the stock in accordance with the rebuilding objective, with the aim of adopting revised conservation and management measures for North Pacific striped marlin at WCPFC17." The United States is considering submitting a proposal on this topic.
