3.1 Updates on the stock status of Pacific bluefin tuna

The last stock assessment for Pacific bluefin tuna was conducted in 2020. Any updates will be introduced on the status of the stock. The JWG will also get an update from the ISC PBF Workgroup on this year's discussions.

3.2 Reports from WCPFC-Scientific Committee (SC) and IATIC-Scientific Advisory Committee (SAC)

WCPFC-SC17 meeting will be held during 11-19 August 2021, after the JWG meeting is concluded. The most recent recommendations can be found in last year's report NC16-IP-02 (*SC16 Summary Report to NC16*).

IATTC-SAC meeting was held during 10-14 May 2021 and provided recommendations to the IATTC Commission as follows:

The SAC recommends the extension of the provisions of Resolution C-18-01, as already extended by Resolution C-20-02, and that the Commission take note that increased catches based on the scenarios analyzed are possible under the harvest strategy prepared by the joint tuna RFMOs Working Group. The choice of catch scenario should take into account the desired rebuilding rate and the distribution of catch between small and large bluefin.

#### 4. Reports on the implementation of Pacific bluefin tuna measures

The JWG-06 will review members' implementation of the conservation and management measures for Pacific bluefin tuna and may clarify any discrepancies if identified.

#### 5. Review of Conservation and Management Measures for Pacific Bluefin Tuna

JWG06 will review the current Pacific bluefin tuna measures of WCPFC CMM 2020-01 and IATTC RESOLUTION C-20-02 and consider any revisions for recommendation to each Commission, if warranted. In preparation for JWG-06, members may wish to also discuss the

WCPFC Harvest Strategy for Pacific Bluefin Tuna Fisheries (HS 2017-02) as well as the IATTC Resolution C-18-02 related to a long-term management strategy for Pacific Bluefin Tuna in the Eastern Pacific Ocean.

The JWG will consider the meeting venue and dates for JWG-07.
