## SUMMARY OF SUBMISSIONS OF ANNUAL REPORT PART 1 AND PART 2 WITH DATES OF dCMR FINALISATION

## Background

1. At the First Regular Session of the Technical and Compliance Committee (TCC1) in December 2005, a two-part reporting format of an Annual Report to the Commission was agreed. The purpose of this report is to provide to the Commission information on fisheries, research and statistics during the preceding calendar year (Part 1), and management and compliance issues since the previous report (Part 2). It was agreed that Part 1 should be submitted one month prior to SC.

2. At WCPFC3 it was agreed that Part 2 should be submitted by 31 July. In 2008, a revised Annual Report Part 1 template was endorsed by SC4. WCPFC5 adopted a set of enhanced guidelines for Annual Report Part 2 recommended by TCC4, and agreed that Part 2 was due one month prior to TCC.

3. At WCPFC8, and in part to accommodate the CMR process, it was agreed that Part 2 reports should be submitted by 1 July.

## **Issues for TCC8**

4. In 2012, there was a continuing trend of Annual Report Part 1 and Part 2 being submitted after the deadline. Table 1 and Table 2 summarize the timeliness of submissions of Annual Reports in 2012, and shows the implications that this has had on the Compliance Monitoring Scheme process. At the time of writing, most Annual Report Part 1 covering 2011 activities had been received; however most were received by the Secretariat shortly prior to or during SC8, which was very close to the deadline for the Secretariat to send out draft CMR sections to CCMs. As at 7 September 2012, seventeen (17) CCMs Annual Report Part 2 reports were still outstanding.

5. On 25 and 26<sup>th</sup> September 2012, the Secretariat provided copies of rough draft dCMR to all remaining CCMs for their information, and in order to assist them with preparing for TCC8 discussions on the Compliance Monitoring Process. In providing these rough draft dCMRs to these CCMs, rough drafts out to the CCMs concerned the Secretariat noted that these were prepared as internal draft, and there had not been time for these drafts to be thoroughly checked, as the intention was to do so once the Annual Reports had been received. Through work that was able to be undertaken by the Secretariat and interns during TCC8, dCMRs were able to be produced for a total of 33 CCMs. Table 3 shows the status of Annual Reports from previous years.
