## **REPORT ON WCPFC HIGH SEAS BOARDING AND INSPECTION SCHEME**

WCPFC-TCC8-2012/IP16

14 September 2012

### Paper prepared by the Secretariat

1. The WCPFC High Seas Boarding and Inspection Scheme (WCPFC HSBI Scheme) was established, in accordance with Article 26 of the Convention, and through the adoption of Conservation and Management Measure 2006-08 *WCPFC Boarding and Inspection Procedures*. At TCC4 (2007), the HSBI paper covered matters of clarification related to the implementation of the WCPFC HSBI scheme. This is the first report prepared by WCPFC Secretariat on the WCPFC HSBI since the scheme became operational.

2. In respect of the WCPFC HSBI, the 2011 WCPFC Performance Review noted that "High Seas Boarding and Inspection is, among others, a salient tool for the purpose of monitoring and ensuring compliance with conservation and management measures on the high seas adopted by the Commission (CMMs), as required by UNFSA. Fishing vessels flying a flag of Members must accept boarding and inspection by a duly authorized inspector in accordance with agreed procedures.

According to Article 26 of the Convention and the subsequent CMM, WCPFC has established a High Seas Boarding Inspection Scheme in a manner fully faithful to the requirements of the relevant UNFSA Articles, i.e., Articles 21 and 22.

... The High Seas Boarding and Inspection Scheme should be assessed when more information becomes available on the Scheme's implementation;"

3. The Secretariat's role in respect of the WCPFC HSBI Scheme includes:

- Maintaining the public webpage (http://www.wcpfc.int/high-seas-boarding-inspection) and keeping pertinent information for the WCPFC HSBI Scheme, such as the HSBI Register of Authorised Inspection Vessels, up to date;
- Advising CCMs by circular, and through the website, of updates to pertinent information related to the WCPFC HSBI scheme;
- Receiving and maintaining copies of notices, final boarding and inspection reports provided by Members that conduct boarding and inspection activities in accordance with the WCPFC HSBI, of other CCMs vessels in high seas waters of the Convention Area; and
- More recently implementing requests from CCMs to receive copies of HSBI reports which the Executive Director has approved be provided in accordance with either paragraph 17 or 18 of the

WCPFC Rule and Procedures Rules and Procedures for the Protection, Access to, and Dissemination of High Seas Non-Public Domain Data and Information Compiled by the Commission for the Purpose of Monitoring, Control or Surveillance (MCS) Activities and the Access to and Dissemination of High Seas VMS Data for Scientific Purposes. Summary information on these requests is included in WCPFC-TCC8-2012-IP05.

4. Currently there are 12 members that have notified the Commission, through the Executive Director, of their intention to participate in conducting boarding and inspection activities under the WCPFC HSBI Scheme. Some have also provided notifications in accordance with paragraph 6 of CMM 2006-08, regarding the application of the WCPFC HSBI to Fishing Entities. A list of these CCMs and the number of vessels included on the Register of Authorised Inspection Vessels (as at 29 September 2012), is shown in Table 1.

5. In 2012, the WCPFC Secretariat has developed a simple database (Microsoft Excel) to summarise the details contained on the WCPFC HSBI activities reports and notices that have been received to date. This development was prompted in part because of the recent interest from CCMs to be able to access copies of WCPFC HSBI reports including requests for reports related to activities in particular geographic areas (eg 100nm high seas buffer around their EEZs). This work was only recently completed, and the information provided in the maps that follow should be considered preliminary analyses of WCPFC HSBI Reports and Notices. The maps following Annex 2 summarize the geographical distribution of boarding

and inspection activities as contained in Inspection Reports provided by four Members to the WCPFC Secretariat in accordance with paragraphs 30 and 31 of CMM 2006-08. Some of the geographic coordinates appear to indicate inspections activities which are not WCPFC high seas areas; and these will need to be clarified with the submitting Member which conducted the inspection activities. A list of the Inspection Reports received to date by WCPFC, by submitting Member that relate to boarding and inspections completed under the WCPFC HSBI Scheme is provided as an Annex 1.

6. To assist with internal record keeping at the WCPFC Secretariat, copies of notifications that are required in accordance with CMM 2006-08 to be submitted by Members to the Commission, can be sent to the Secretariat to email: contact.hsbi@wcpfc.int

7. Although outside the scope of the WCPFC HSBI Scheme, the WCPFC Secretariat notes that some CCMs have provided summary information in their Annual Report Part 2 regarding the outcomes of boarding and inspections that have been conducted on their flagged vessels, in the previous calendar year, in the high seas of the Convention Area. CCMS may have also noticed that the Secretariat included in this years draft CMR template (2011 activities) a field related to any HSBI infringements during 2011.

# Future work related to the High Seas Boarding and Inspection Scheme

8. Some proposed future tasks for the WCPFC Secretariat in respect of the High Seas Boarding and Inspection Scheme, include:

- Development of a dedicated WCPFC HSBI Scheme module within the WCPFC MCS Information Management System based at the Secretariat in Pohnpei (building on the current Microsoft Excel summary spreadsheet which was used as a basis for the analyses in this Report, and linking to other WCPFC MCS information including the WCPFC Record of Fishing Vessels); and
- Examining the development of a database which could provide access to summary details of WCPFC HSBI Reports, for the reference of authorized MCS personnel, through the CCM-only section of the WCPFC website, in support of high seas MCS activities.

Completion these tasks, particularly the latter, will be subject to necessary funds being secured and prioritized as part of the approved WCPFC work programme and budget. This will be further elaborated in the relevant TCC paper (WCPFC-TCC8-2012-21).

9. The WCPFC has received some queries from CCM MCS contacts regarding details of the "list of authorities of the fishing vessel", so as to assist with ensuring that notices provided under paragraph 20d) of CMM 2006-08 and Inspection Reports under paragraph 30 are properly received by the authorities of the fishing vessels when boardings and inspections take place in accordance with the WCPFC HSBI Scheme. In these cases the WCPFC Secretariat has provided recent official contact details for the CCM concerned. It would assist the Secretariat if CCMs (particularly those not currently included in the list) could advise the Secretariat if there are contact persons other than the official contacts, to be their "authorities of the fishing vessel" for the purposes of the WCPFC HSBI Scheme.

10. This paper is proposed to be "a matter to be discussed by exception during TCC8. In any case the Secretariat would welcome direct feedback from CCMs on the usefulness of this report, and whether there is additional information on the WCPFC HSBI Scheme that CCMs would like to see in future reports or made available through the WCPFC website, including through the CCM-section of the WCPFC website.
