#### **Purpose**

 This paper provides for information of TCC17 the updated versions of tables and notes that summarize the reports made in 2018, 2019, 2020 and part of 2021 by CCMs under CMM 2017-01, CMM 2018-01 and CMM 2020-01 of the *Conservation and Management Measure for Bigeye, Yellowfin and Skipjack*. The information in this paper is based on recent information received by the Secretariat. It should be noted that some related replies to CMR or recent reporting may not be reflected in this paper.

- 4. The applicable WCPFC decisions and notes on the WCPFC IATTC Overlap Area are as follow:
  - (a) The WCPFC9 decision on the application of measures in the part of the WCPF Convention Area that overlaps with the IATTC Convention Area says that in the case of a WCPFC member who is also an IATTC member, and who has vessels on both records/register of IATTC and WCPFC, the corresponding flag Member shall decide and notify both organisations under which of the two Commission measures those vessels shall operate when fishing in the overlap area with IATTC and WCPFC. If a CCM is a member of only one RFMO, the rules of that RFMO will apply in the overlap area between WCPFC and IATTC, even if the CCM is a cooperating non-member of the other RFMO. (see WCPFC9 Summary Report, paragraph 80)

#### (b) CMM 2018-01 paragraph 10 states that:

Where flag CCMs choose to implement IATTC measures in the overlap area, any calculation of limits for the Convention Area (excluding the overlap area) that are done on the basis of historical catch or effort levels, shall exclude historical catch or effort within the overlap area. Notwithstanding decisions on application of catch and/or effort limits, all other provisions of this measure apply to all vessels fishing in the overlap area.

- (c) In 2020, the Secretariat received one update on 8 July 2020 of Member's choice of WCPFC/IATTC measures in the Overlap Area.<sup>23</sup> No notifications were received during 2021. Accordingly, in 2018, 2019, 2020 and 2021, or as otherwise specified the following six CCMs could apply IATTC measures in the Overlap Area: <sup>24</sup>
  - Ecuador As a WCPFC Cooperating Non-Member which is a contracting party of IATTC:
  - El Salvador As a WCPFC Cooperating Non-Member which is a contracting party of IATTC;
  - Panama As a WCPFC Cooperating Non-Member which is a contracting party of IATTC;
  - European Union In accordance with letter received by WCPFC on 2 April 2013:
  - Commencing February 2019 Nicaragua As a WCPFC Cooperating Non-Member which is a contracting party of IATTC; and
  - Commencing 8 July 2020, the United States of America In accordance with letter received by WCPFC on 8 July 2020.

- 6. During 2018, the United States provided four quarterly reports to date, in respect of the utilization of its EEZ limit during 2018 (CMM 2017-01 paragraph 29). The United States notified that the U.S. EEZ limit was not reached by October 1, 2018, so no further changes were authorized.
- 7. No notifications were received during 2021 related to notification of EEZ limits for purse seine effort and/or catch of skipjack, yellowfin and bigeye tuna (CMM 2018-01 paragraph 25). Previously the following notifications of EEZ limits for purse seine effort and/or catch of skipjack had been received:
  - Philippines At WCPFC16 the Commission noted that the Philippines submitted DP25. The Philippines advised this was set at 42,000 fishing vessel days in lieu of

- the original submission, based on the current capacities and conditions of the small purse seine fishing vessels operating in the Philippines Pacific seaboard EEZ. These include wooden hulled ring net/purse seine fishing vessels.
- o Indonesia via letter to the Secretariat dated 8 September 2020 the Secretariat received formal notification of the limit of 70,820 Mt.
- Chinese Taipei 59 days (~34 purse seine vessels)

The Republic of Korea has also clarified that CMM 2017-01 paragraph 25 and CMM 2018-01 paragraph 25 does not apply to Korea.
