UNDER CMM 2009-06 FOR PHILIPPINE FLAGGED VESSELS THAT WILL OPERATE
IN HIGH SEAS POCKET NUMBER 1**

Dear Prof. Hurry,

I hope that all is well with you today.

Please be informed that the Philippines is submitting its list of Philippine flagged vessels that will operate in High Seas Pocket Number 1 in accordance with CMM 2011-01 and Fisheries Administrative Order Number 245 which became effective this August 21, 2012. As soon as CMM 2011-01 was approved, the Philippines started work on the development of its domestic rules on implementing the same.


The list of catcher vessels which do not have any operational fish hold includes that of its corresponding carrier vessels which has the operational fish hold. The case of the Philippines' group purse seine operations is well document and its request for operations in the High Seas Pocket Number 1 had been discussed for at the very least two years. The main species to be transhipped and product form is fresh chilled skipjack by ice carriers. The area of operations of these Philippine flagged vessels are in the High Seas Pocket Number 1 for the duration of CMM 2011-01 and its successor CMM.

Attached are the copies of the list of these concerned Philippine flagged vessels.

We will appreciate it if this request is circulated in time for TCC8 and included as an agenda item.
