CNM REQUESTS IN 2021

WCPFC-TCC17-2021-07_rev1¹ 20 September 2021

Paper by the Secretariat

Purpose

1. This paper presents the requests received for Cooperating Non-Member (CNM) status for 2022 for the consideration and decision of TCC17.

Background

2. On 10 March 2021, the Executive Director sent letters to all 2021 CNM applicants, confirming the outcomes from WCPFC17 in relation to their CNM requests and the financial commitment expected from each successful CNM applicant for 2021. The letter also drew attention to the latest version of the electronic form to be used when requesting CNM status be granted for 2022 which is available on the WCPFC website (at https://www.wcpfc.int/doc/commission-07b/cooperating-non-member-request-template).

CNM requests for 2022

3. To date, the Secretariat has received eight (8) requests for granting of CNM status in 2022 (see **Table 1**). All requests were submitted using the electronic form and most were accompanied by a supporting letter.

4. The requests are from eight of the nine countries with CNM status for 2021. The ninth country, The Bahamas, sent a letter to the Executive Director on 18 July 2021 stating that, 'owing to administrative difficulties associated with maintaining effective participation in the Commission activities it has been decided not to apply for CNM status renewal for year 2022'. For this reason, they have also indicated The Bahamas may not be able to participate in TCC17 or the 18th Regular Session of the Commission in December 2021. However, they have stated they will remain as a CNM for the remainder of this year and fulfill all associated obligations.³

CNM Financial Contributions for 2021

5. **Table 2** provides an update on payment of financial contributions for 2021 as at 20 September 2021.⁴

7. The Secretariat has prepared a draft Compliance Monitoring Report covering 2020 activities for the relevant eight current CNMs (Curacao, Ecuador, El Salvador, Liberia,

Nicaragua, Panama, Thailand and Viet Nam)⁵. As has been the case in past years, the information for CNMs is expected to be considered alongside the draft Compliance Monitoring Reports of Members and Participating Territories, and as part of the Compliance Monitoring Scheme process (CMM 2019-06).

Recommendation

8. TCC17 is invited to consider the requests for CNM status for 2022 and make recommendations and technical advice to the Commission. It is expected that a working group will develop draft recommendations for TCC17 to consider.
