## AGENDA ITEM 1. OPENING OF THE MEETING

The Session will open at 14:00 on Sunday, 2 December 2012.

The Chair Dr Charles Karnella will welcome delegates from WCPFC Members, Cooperating Non-Members and Participating Territories (CCMs) and Observers.

The provisional agenda for WCPFC8 was prepared and distributed on 22 October 2012. The Rules of Procedure provide that Members may propose supplementary agenda items up until 30 days before the meeting (Rule 3) (2 November 2011). The Agenda, as modified, will need to be adopted by the meeting (Rule 5).

The Commission will review the Indicative Schedule. The Chair, through the Secretariat, will outline any logistical and administrative arrangements in place to support the meeting, proposed meeting times and any social engagements.

## AGENDA ITEM 2. MEMBERSHIP AND OTHER APPLICATIONS

## 2.1 Status of the Convention

The Commission will receive a brief report from New Zealand on the status of the Convention.

## 2.2 Applications for Observer status

In accordance with Rule 36 of the Commission's Rules of Procedure, the Commission will be advised of any applications for observer status that were received from non-government organisations 50 days in advance of the Session (13 October 2012). The Commission will be advised of those observers that were subsequently invited to participate in the Session.

## 2.3 Applications for Cooperating Non-Member status

The Commission will consider applications for Cooperating Non-Member (CNM) status for 2013 and decide on granting CNM status to applicants for 2013. The advice and recommendations of the TCC8 in relation to applications received, considered on the basis of procedures provided for in CMM 2009-11 will be available to the Commission. In accordance with paragraph 12 and 13 of CMM 2009-11, the Commission may review the limits of participatory rights of CNMs under CMMs.

## 2.3.1 IATTC/ WCPFC Overlap area.

WCPFC8 agreed that this issue of the overlap area needed to be resolved as a matter of priority and asked the Chairs and Executive Directors of the two RFMOs to progress the issue, and report back to CCMs. The Executive Director will report the progress of joint management agreement with IATTC for the overlap area and the Commission is invited to consider any further actions to be taken.

## AGENDA ITEM 3. EXECUTIVE DIRECTOR AND CCM REPORTS

## 3.1 Report of the Executive Director on the work of the Commission

The Chair will invite the Executive Director to present the annual report on the work of the Commission for the 2012 calendar year and to highlight future work and budget issues for the Secretariat and the Commission. Hard copy and/or electronic versions of this report should be forwarded to the Executive Director at least 30 days in advance of the

Ninth Regular Session of the Commission (WCPFC9). Non Members are also encouraged to table any additional information in annual reports for circulation.

## AGENDA ITEM 10. CONSERVATION AND MANAGEMENT MEASURES

#### **10.1** Consideration of new CMMs and other conservation requirements

The Chair will go though the list of proposed CMMs and take any others that CCMs may have provided proposals. In addition to the CMM on bigeye, yellowfin and skipjack, there are expected to be:

- three potential new measures;
- three revisions of existing CMMs; and
- two processes to develop a proposal or revise a current CMM to be considered at WCPFC9 for possible adoption.

## **10.1.1** Scheme for minimum standards for inspections in port.

TCC8 supported the development of a WCPFC CMM for Port State Measures. TCC8 recommends that the EU provide a draft of the new CMM to members as soon as possible and encourages all members to contribute with a view to reaching an agreement at TCC9 unless substantial progress is made before WCPFC9.

#### **10.1.2** Prohibition of purse seine fishing associated with whale sharks

In considering the draft measure on protecting whale sharks from purse seine fishing operations, WCPFC8 noted ongoing work, through the Scientific Committee, on the development of best practice guidelines for release of encircled whale sharks. Based on the current draft measure, the Commission agreed to finalise the measure at WCPFC9.

#### 10.1.3 Catch documentation scheme

TCC8 recommended that the EU and FFA members work to finalize the TOR on CDS prior to WCPFC9 noting that the new proposal needs to be circulated 30 days prior to WCPFC9.

WCPFC8 agreed that South Pacific Albacore was a priority issue for WCPFC9. TCC8 recommended sufficient priority be accorded to the development of a revised CMM on south Pacific albacore at WCPFC9.

WCPFC8 agreed that the USA would lead an intersessional working group on this topic with the aim of bringing a proposal to TCC8.

#### **10.2** Report by PNA members on the vessel day scheme

WCPFC4 (paragraph 325) noted that the Vessel Day Scheme (VDS) was operational and that the VDS is the measure adopted by PNA Members of the Commission for managing capacity and fishing effort in the EEZs of PNA Members. It was agreed that the PNA would provide a report to the Commission on the implementation of the VDS at each annual session of the Commission.

## AGENDA ITEM 11. AD HOC TASK GROUP – DATA

#### **11.1 Chartering State data access**

In 2011, the Commission had tasked the AHTG-Data to work intersessionally during 2011 on this matter. RMI submitted a proposal, and comments were received from EU and Chinese Taipei. WCPFC8 noted the TCC7 recommendation to task the AHTG-Data with revisiting these issues in 2012 pending the outcome of discussions of the catch attribution study and the possible renewal of CMM 2009-08 by WCPFC8. TCC8 made a recommendation to the Commission on this (TCC8 draft report para 365).
