Dear Dr. Franco and Ms. Moss-Christian,

The Co-Chairs of the IATTC – WCPFC Northern Committee Joint Working Group on the Management of Pacific bluefin tuna (JWG) would like to announce the 3<sup>rd</sup> intersessional meeting to be held on 11 – 13 March 2026 in California, USA. The Co-Chairs would like to thank the United States for offering to host the meeting.

In July 2025, the 10<sup>th</sup> JWG meeting progressed discussions on the Pacific bluefin tuna (PBF) long-term harvest strategy, the development of the PBF catch documentation scheme (CDS) and reviewed Monitoring Control and Surveillance (MCS) measures. The Co-Chairs and JWG members continued conversations on the long-term harvest strategy and harvest control rules on the sidelines of the IATTC and WCPFC annual meetings in September and December, respectively. JWG members expressed their interest in holding an intersessional meeting to continue to advance these discussions ahead of JWGI-11 in July 2026.

We will work with the United States to confirm the detailed meeting arrangements and share additional information with both Commissions as soon as possible. For planning purposes, we anticipate that the meeting will be held in Los Angeles or San Diego, and we are exploring options for hybrid participation.

We would appreciate your assistance in sharing this announcement with all parties.
